Applications and fees postmarked, and-delivered, or faxed on or prior to Tuesday May 20, 2008 will be charged \$35 per application. Applications and fees postmarked, hand-delivered, or faxed after Tuesday May 20, 2008 and received by USHJA on or before June 17, 2008 will be charged an application fee of \$150 per application. **HOWEVER, NO APPLICATIONS SHALL BE ACCEPTED UNLESS RECEIVED ON OR BEFORE Tuesday June 17, 2008. NO APPLICATIONS SHALL BE ACCEPTED IF THE APPROPRIATE APPLICATION FEE IS RECEIVED AFTER Tuesday June 17, 2008. IN THE EVENT AN APPLICATION IS RECEIVED WITHOUT THE APPROPRIATE APPLICATION FEE, THOSE APPLICATIONS SHALL BE ACCEPTED ONLY IF THE APPROPRIATE APPLICATION FEE IS RECEIVED BY Friday June 20, 2008.**
