

## LICENSE APPLICATION DISPUTE FORM

Any competition license applicant may dispute the denial of a license application or renewal. In addition, a Mileage Exemption Request applicant and Priority Date Holder(s) may dispute a mileage exemption request decision. Chapter 3 of the Federation's rules provides the process by which the aggrieved party may file a dispute with the Federation Hearing Committee. (See Chapter 3).

This complaint form must be used when filing a license application/renewal or mileage exemption request dispute. A dispute that is not filed in accordance with Federation Rules shall render the filing ineffective and the dispute shall not be considered to have been properly filed. The dispute shall be filed with the Federation Regulation Department at <a href="mailto:epratt@usef.org">epratt@usef.org</a>. Any questions should be directed to the Director, Regulation Department at <a href="mailto:epratt@usef.org">epratt@usef.org</a>.

The form and filing fee must be received by the Federation within 10 calendar days of the date of the Federation notice of approval or denial. Please use one form per dispute and note the filing fee must accompany each dispute form.
