## DIRECTIONS

\*Buchanan Hall address - 8549 John Mosby Highway (US-50) Upperville, VA 20814

\*Grafton Park Show Grounds address – 8600 John Mosby Highway Upperville, VA 20814

From Washington Dulles Airport to Buchanan Hall – take VA-267 West (partial toll road), take exit 8A for VA-606 W/Old Ox Rd (toll road) and turn right, go 6 miles then right on John Mosby Hwy/Lee Jackson Memorial Hwy/US-50 W, at traffic circle take 2<sup>nd</sup> exit and stay on John Mosby Hwy, at traffic circle take 1<sup>st</sup> exit and stay on John Mosby Hwy for 14 miles, Buchanan Hall is on the left

From Reagan Washington Airport to Buchanan Hall – take George Washington Memorial Parkway, exit onto I-395 South, take exit 8B to VA-110 North, exit onto I-66 West for 50 miles, exit onto US-17/VA-55/Winchester Rd for 8 miles, turn right on John S Mosby Hwy/US-50 E, Buchanan Hall is on the right  
Buchanan Hall to Grafton Park Showgrounds – left onto John Mosby Highway, go .2 miles – on the right
