DIRECTIONS

From LAX to hotel – Take the I-405 North to 101 Freeway South, continue on CA-134 East toward Burbank/Glendale, take the Pass Ave exit toward Burbank, turn right on N Pass Ave, turn left on W. Alameda Ave, turn left on S. Buena Vista St, turn right on W Empire Ave.
