AIRPORTS

Newark Liberty International Airport (EWR) - Newark, New Jersey – 51 miles to hotel

Lehigh Valley International Airport (ABE) - Allentown, Pennsylvania – 37 miles to hotel

DIRECTIONS

From EWR to hotel –take US-1 N/US-9 N/US-22/NJ-21 ramp towards NJ-21 N, take NJ-21 N for 3 miles, turn right on Bridge St, continue onto Harrison Ave, turn left on N 2nd St, turn left on I-280 W and go 14.8 miles, take I-80 W for 19.2 miles, take exit 26 for US-46 W toward Budd Lake/Hackettstown and go 8 miles, turn left on Mountain Ave and go 1 mile, turn right on NJ-57 W, go ¾ mile hotel is on right

From ABE to hotel – southeast on Hayden Cr toward Postal Rd, slight left at Postal Rd, turn right at Airport Road/PA-987, merge on to US-22 E via the ramp to Bethlehem for 16 miles, slight left at NJ-57 and go 20 miles, hotel on left

From Comfort Inn to Centenary College – turn right on Route 57, go through 2 lights and turn left on the next road- King's Highway, go all the way up the hill and at stop sign turn right on Pleasant Grove, turn left on Califon Rd, Equestrian Center is one mile on the left **If using GPS use address 35 Califon Rd. Long Valley, NJ 07853 and Equestrian Center is across the street
