DIRECTIONS

Bluegrass Airport to Hotel- exit airport left onto Man O' War Blvd, turn right on Versailles Rd, take ramp onto New Circle Rd North, take Exit 9B for KY-922 N/Newtown Pike towards interstate, hotel is on right

From North (Cincinnati) to Hotel - take I-75 South to exit 115 Newtown Pike KY-922, turn left on Newtown PK, hotel is on right

From West (Louisville) to Hotel - take I-64 East to exit 115 Newtown Pike KY-922, turn left on Newtown PK, hotel is on right

From Hotel to USEF- turn right on to Newtown Pk, go 2 miles and turn left on Iron Works Pike (4-way stop), use KY Horse Park main entrance (past the campground entrance)
