DIRECTIONS

From Bluegrass Airport to Hilton Georgetown: exit airport and turn left on Man O' War Blvd, turn right on Versailles Rd, take the second New Circle Road entrance, go 5 miles and take exit 9B Newtown Pike/KY-922, continue for 2 miles, then take I-64 W/I-75 N towards Cincinnati, keep on I-75 N and go 9.7 miles, take exit 125 for US-460, turn left onto US-460 and then take the 2nd right onto Cherry Blossom Way, take 2nd left onto Champion Way, turn right on Grandstand Dr.

From Hilton Georgetown to USEF: turn left on Champion Way, turn left on Cherry Blossom Way, merge onto I-75 S and go 5.2 miles, take exit 120 Iron Works Pk and turn left, turn left into KY Horse Park main entrance, take the first exit out of the roundabout towards the right and proceed until the road turns left, USEF is the second building on the right with the flags. Please park in the parking area directly across from building.
