AIRPORTS

Lexington Bluegrass Airport (LEX)

Cincinnati/Northern Kentucky International (CVG) – 75 miles from Lexington

Louisville International (SDF) – 75 miles from Lexington

DIRECTIONS TO GRIFFIN GATE MARRIOTT

From Bluegrass Airport- exit airport left onto Man O' War Blvd, turn right on Versailles Rd, take ramp onto New Circle Rd North, take Exit 9B Newtown Pike towards Interstate, hotel is 1.5 miles on right

From I-75/64 – take Exit 115 (Newtown Pike/SR 922) off I-75/64. Head south to second light, hotel on left

From Four Points Sheraton - turn left on to Newtown Pk from Stanton Way, hotel is approx. 1 mile on left.

From Hotels to USEF- turn right on to Newtown Pk, go 2.5 miles and turn left on Iron Works Pike (4-way stop), use KY Horse Park main entrance (past the campground entrance). Bear right out of the roundabout and proceed until the road turns left. USEF is the second building on the right with the flags. Please park in the parking area directly across from building.
