DIRECTIONS

From Baltimore Airport to Hampton Inn: Take I-195 W to exit 4A, merge onto I-95 North (toll road), take exit 77A for MD-24 South, take first right on Edgewood Rd, take first right on Emmorton Park Rd. Hotel is on the left.
