Rule Change Intent

Based on feedback received from competitors and organizers, as well as discussions with USHJA leadership, the opportunity exists to create greater accessibility to equestrian sport for competitors and organizers by making some adjustments to the Channel 2 competition format.

This proposal addresses the feedback received about the distinct Channel 2 HOTY awards, permitting results of Channel 2 competitions to also count for Channel 1 HOTY awards/qualification for Channel 1 major events, reducing the maximum number of classes permitted per section at multi-day Regional competitions, and limiting the number of Regional competitions permitted each competition week per venue and/or organizer.

This rule change proposal supports the opportunities noted above and supports the diversity of event ratings/levels and venues to meet the developmental needs of competitors and horses.

SUBCHAPTER 3-B COMPETITION CLASSIFICATION

GR311 Awards Rating Classifications

 For the purpose of equalizing competitions for the National HOTY Awards, divisions and sections of Regular competitions fall into one of three classifications: Premier, National or Regional Hunter.
 In the Hunter division, points for ribbons won in any rated section will be awarded in two awards channels using the applicable point chart. Channel I includes Premier and National rated hunter competitions and Channel II includes Regional rated hunter competitions. Points earned in a-Channel I are exclusive to that award channel. Points earned in Channel II are applicable to both Channel I and Channel II.

a. In the Green Hunter 3'0", 3'3", 3'6" and 3'9", Young Hunter 5 and under, Young Hunter 6 and under, Young Hunter 7 and under, High Performance Hunter, Performance Hunter 3'3" and 3'6", Green Conformation Hunter 3'6" and High Performance Conformation Hunter, standings for the National HOTY Awards based on money won will be determined by dollars won in the horses respective sections. Extraordinary Change Reason							

Horses must be fit to compete at all times while participating in Federation licensed competitions. The discovery of blood on a horse, whether actively bleeding or evidence of recently having bled, may be grounds for elimination. Instances of blood in the mouth or flank, as well as blood caused by tack and equipment must result in elimination from further competition. In minor cases of blood, from a horse biting its tongue or lip, a participant may be permitted to rinse the horse's mouth and, if the bleed ceases, continue on in competition. All other blood discovered by a judge, Steward, or Technical Delegate may result in elimination at the discretion of the official.

GR843 Blood

See section and division rules for additional restrictions and/or penalties for the prescence of blood.

- Blood on horses must be reviewed on a case-by-case basis. Eliminations for blood are final.
- A licensed judge or the Ground Jury must stop the class for the examination of any horse with blood in its mouth or elsewhere on its body.
 - a. In minor cases of blood in the mouth, such as where a horse appears to have bitten its tongue or lip, the licensed judge or the Ground Jury may authorize the rinsing or wiping of the mouth and allow the horse to continue. If the horse continues to bleed, it will result in elimination from the relevant class.
 - In all other circumstances, any horse with blood in its mouth must be eliminated from the relevant class.
 - c. Blood discovered elsewhere on the horse's body may result in elimination of the horse in the discretion of the licensed judge or the Ground Jury. If the blood is determined by the licensed judge or the Ground Jury to be athlete induced or caused by tack or equipment, the horse must be eliminated from the relevant class.
- Where a horse is eliminated from a class that is a qualifier for a championship or other class, the eliminated horse may compete in the championship or other class, if the horse is otherwise qualified to do so and the blood is resolved prior to the championship or other class.

Rule Change Intent

Currently, points and money won earned at Regional hunted rated competitions only count towards Channel II awards in the USEF National HOTY program. Competitor and organizer feedback indicates that there would be substantially more Regional rated hunter competitions if HOTY points from these events counted for Channel I and Channel II of the USEF National HOTY awards program.

This proposal is linked to an existing standard rule chage to effectuate the change to allow points and money won from Regional hunter rated competitions to count for both Channel I and Channel II USEF National HOTY awards.

Since Regional rated hunter comeptitions would count for both Channels, it is important that a mileage boundary is established between Regional rated hunter competitions and National/Premier rated hunter competitions. This proposal would create that mileage boundary and both rules if approved would come into effect simultaneously for the 2027 USEF competition year.
