USEF Eventing Rule Updates

Approved Eventing chapter rules: [Review the approved rule changes for the Eventing Chapter here](#). These rules will go into effect December 1, 2025.

Approved General Rules Chapters: Review the approved rule changes in the General Rules Chapters applicable to Eventing [here](#). These rules will go into effect December 1, 2025. All rule changes approved by the USEF Board can be found on the USEF website [here](#).

As a reminder, on December 1, 2025, the following two rules will also go into effect:

- **[GR1101.10 \(Microchip\)](#)**: All horses competing at Federation Licensed and Endorsed competitions must provide a microchip number that verifies the animal. Find more information and resources about microchipping on the dedicated [Equine Microchipping webpage](#) and in this [letter to Eventing Competition Organizers](#).
- **[EV Appendix 2 3.5 \(Preliminary MER\)](#)**: Athletes must have obtained one MER at the Modified level or higher and five MERs at the Training level or higher.
