

Steward/TD Report Updates

The Competition Report Dashboard can be accessed via the Licensed Officials Dashboard.



INTRODUCTION

The Steward/TD Reports have been updated in hopes of creating a more interactive and correct report. These changes include design updates, the ability for multiple Stewards/TDs to edit the same report, and any follow-up required to be completed within the original report.

Accessing your Steward/TD report will look the same.

You can access the Competition Report Dashboard by following these steps:

1. Log in to your online USEF account at usef.org
2. Click on the Licensed Officials Dashboard tile
3. Scroll down to the Licensed Officials Tools section and click on the Competition Report Dashboard tile
4. To view more information about a specific competition, click on a competition



DESIGN UPDATES

Once a competition is selected from your Competition Report Dashboard, a small box will show up with additional competition information. Select *CONTINUE* if this is the competition you wish to start a report for.

*Please note selecting *CONTINUE* does not confirm the competition information (manager, secretary, dates, location). This will only confirm that this is the competition you wish to continue with.

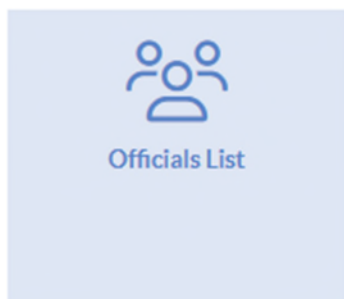
SUMMARY

CONTINUE

Once all sections are completed, navigate to the summary screen for submission. Scroll to the bottom of the summary screen, sign off on the report and hit Submit. Once submitted a flag will show at the top of the summary screen confirming submission. You will receive an email confirming your submission as well.

OFFICIALS

The competition officials will now be edited within the Officials List tile found within your Competition Report Dashboard.



This tile will bring you to a list of all officials for that competition with the ability to edit, add, and delete as necessary. This should allow any changes to be made quickly and easily without having to enter the report. This tile will also show any ineligibility to ensure any issues can be caught quickly.
