Re: Information on the 2027 USEF Grand Prix Dressage National Championship

This preliminary information is being provided to assist you with your competition planning and may be subject to change. Please remember that this information is based upon the recommendations of the USEF Dressage Sport Committee and the final qualifying requirements are subject to approval by the USEF Board of Directors or the USEF Executive Committee.

The purpose of this memo is to advise all dressage competitors that the 2027 USEF Grand Prix Dressage National Championship ("Championship") will not be part of the 2027 U.S. Dressage Festival of Champions. It is anticipated that this Championship may serve as part of the selection process for the 2027 U.S. Pan American Games Team.

Please be advised that the following is anticipated concerning the qualifying requirements for this Championship:

- The Championship will be held over one weekend. The date and location of the Championship will be announced by December 1, 2026. Tentatively, this Championship will be held in May 2027.
- The qualifying period for this Championship will begin on August 26, 2026.
- All combinations wishing to compete in this Championship must meet the FEI qualification criteria in accordance with the current edition of the FEI Dressage Rules, Articles 429 and 433. The rules can be found on the FEI website [here](#).
- Combinations are required to earn scores at FEI events only to qualify for this Championship. Qualifying competitions include all U.S. and foreign CDI3*, CDI4*, CDI5*, CDIO, CDI-Am and CDI-W events within the qualifying period. The US Open Dressage Final scheduled on November 13-14, 2026, and the FEI World Cup Final scheduled on March 24-28, 2027, in Gothenberg (SWE) are considered qualifying competitions.
- Combinations will be required to earn a minimum of two (2) scores in the FEI Grand Prix Test, a minimum of two (2) scores in the FEI Grand Prix Special Test and compete in a minimum of one (1) FEI event after December 1, 2026.
- The USEF Dressage Grand Prix 8-Month Ranking List will be utilized for this Championship ([found here](#)).
- The FEI Dressage and Equine Anti-Doping and Control Medication Regulations ([found here](#)) will be used for this Championship. This may include the FEI Veterinary Regulations for secured stabling and accreditation.

Information regarding selection for the 2027 U.S. Pan American Games will be published on the USEF website [here](#) in the Fall of 2026. Please be advised that all applicant athletes and horses are subject to drug testing both in and out of competition.
