

## **USEF Competition Lite**

The Board voted to approve the re-launch of Competition Lite. This paves the way for the new Lite rules to be added to Chapter Three (3) of the USEF Rule Book beginning in the 2023 competition year and USEF Lite will be classified as a sub-type of a Federation Local license.

The purpose of the Lite program is to promote USEF and grow the competition environment. It will provide organizers of new, smaller, or formerly unlicensed competitions across the national breeds and disciplines with an entry point to the licensed competition environment by offering discounted fees and fewer barriers to entry. The program allows them to establish and grow their competitions under the USEF framework of organized sport with a goal of eventually transitioning those to Regular competitions. A summary of the Lite structure is provided below:

Competitions for any breed or discipline that are eligible for a Local license type could choose to apply for a Lite competition if it:

- 1) has never been previously licensed by the Federation; or
- 2) has not been licensed by the Federation in the past three years; or
- 3) has operated exclusively as a Lite competition in any of the past three years; or
- 4) does not meet any of the three prior eligibility requirements, and it is granted an exemption at the sole discretion of the Federation's Chief Executive Officer.

Lite competitions may operate for a maximum of three years, but it is important to note that beginning with the 2023 competition year, all previously licensed Lite competitions will be considered new Lite competitions and will be able to operate for the full three years, regardless of the number of times they operated as Lite competitions in the past.

## Savings for competition management

- A Lite competition will have a discounted application fee of \$50 (a \$50 savings from the Regular license application fee) and the \$1.50 per horse fee is waived for Lite licensed competitions.
- Management has more flexibility regarding who they can hire as officials (i.e., either a fully licensed Steward/TD, or someone enrolled and currently pursuing a USEF Steward/TD license who has completed the Designated Applicant Training).
- Additional financial support is provided through access to Competition Manager Perks which provides discounts on products and services, such as Electronic Vet, Horseshoe Greetings, Big Ass Fans, and Office Depot.

## Savings for exhibitors

Exhibitors pay no USEF participation fees (Membership, Administrative, Drugs & Medication fees, etc.); however, drug testing may still occur, and all participants are subject to the applicable D&M rules.
 Exhibitors are not required to be USEF or breed/discipline affiliate members (unless HOTY points are desired) or pay show pass fees.

## Additional benefits for Lite competitions

- USEF Safe Sport: Participants in a Lite competition will be under the jurisdiction of the
  U.S. Center for Safe Sport and will be subject to the U.S. Center for SafeSport Code and
  USEF Safe Sport Policy and afforded all related protections.
- Regulatory function: a Lite competition will be granted access to the Federation's regulatory functions at no additional cost, which can assist organizers in enforcing rules and dealing with non-payment of competition fees (i.e., collection of bounced checks and declined credit cards).
- Mileage boundary: there is a 50-mile boundary protection to ensure a competition is not competing for exhibitors with another nearby licensed competition.
- Staff support: USEF staff support is always a call or email away 24/7 to assist when questions arise before, during, and/or after a show.
