Comments are required for ratings of 6 and below (no half marks given), and appreciated for all other ratings.
- A Passing score of an 85% (102 points out of 120 total) is necessary for this apprenticeship experience to count towards the U.S. FEI licensing requirements. A passing score represents that the evaluator recommends this individuals for promotion to an FEI Level 2 Dressage Steward.
