The Selection Procedure for the 2022 FEI World Championship Show Jumping Team are now available on the <u>US</u> <u>Equestrian Jumping page</u>. The application, required documents and payment must be submitted electronically. Please read this memo, the Selection Procedures, and Application carefully and do not hesitate to contact us if you have any questions.

Before you start, you must have completed the following items:

- The athlete must have a 2022 FEI Registration;
- The athlete must have a 2022 USEF Membership;
- The horse(s) listed must have a 2022 FEI Registration;
- The horse(s) listed must have an active USEF recording.

## USEF World Championship Application:

The USEF World Championship Application is available through your online <u>Member Dashboard on your</u> <u>MY USEF</u>. Be sure to have your USEF Membership ID and Password available. Once you sign in, click on Athlete Dashboard, then Online Applications, then Jumping 2022, then select 2022 FEI World Championship Jumping Application.

**Deadlines & Fees:** Please note the Application paragraph in the Selection Procedures (I.A.3.c), and be aware that the all deadlines and fees will be adhered to **without exception**.

- The Phase I Application Deadline is Monday January 3, 2022 at 11:59pm ET Fee: \$70 \*Average List Applicants Only
- The Phase II Application Deadline is Monday April 4, 2022 at 11:59pm ET Fee: \$70
- The Phase II Late Applications Deadline is Monday April 11, 2022 at 11:59pm ET. Fee: \$300
  - No Applications will be accepted after April 11, 2022 at 11:59pm ET

Horses: It is possible for an athlete to request to be considered with an additional horse(s) after the athlete has submitted their application. Athletes wishing to be considered with additional horse(s) must indicate this request in writing to Lizzy Chesson (lchesson@usef.org) no later than April 11, 2022.

**Confirmation:** Upon receipt of your online application and fee, you will receive an email confirming the date your application and payment was received. If you do not receive an acknowledgement of your application, it is your obligation to contact the USEF to determine if it has been received.
