Athletes wishing to be considered for The Dutta Corp. U.S. Dressage Team must complete the **2022 FEI Dressage World Championships USEF Online Application (for Dressage).** The application required documents and payment must be submitted electronically.

This application is available through your online Member Dashboard on your MY USEF. Be sure to have your USEF Membership ID and Password available. Once you sign in, click on *Athlete Dashboard*, then *Online Applications*, make sure to search for applications for '2022' then *Apply* for the 2022 FEI Dressage World Championships Application.

Deadlines & Fees: Please note the application paragraph in the Selection Procedures (I.A.4.c) and be aware that all deadlines and fees will be adhered to without exception.

• Wednesday, March 2, 2022 11:59 PM EST Application Deadline and Fee \$70

• Wednesday, March 9, 2022 11:59 PM EST Late Application Deadline and Fee \$300 March 9, 2022 is the last date an application can be accepted.

Application & Payment Confirmation: Upon receipt of your application and fee, you and your horse owner(s) will receive an email confirming the date your application and payment was received. If you do not receive an acknowledgement of your application, IT IS YOUR OBLIGATION to contact USEF to determine if it has been received.

Clean Sport

Please remember athletes must adhere to all WADA, FEI, USOPC, and USADA anti-doping protocols, policies, and procedures, and may be drug tested. FEI Registered Athletes are subject to in-competition and out-of-competition drug testing at anytime. Please contact Steven Morrissey with any questions at (859) 225-7686.

All horses that are registered with the FEI or USEF shall be subject to in-competition testing. FEI's philosophy is that horses must be "clean" at the time of competition. If seeking advice from a veterinarian ensure he/she is a registered FEI veterinarian and is fully conversant with the FEI Veterinary Rules the Prohibited Substance List.
