Chapter 1. General Licensing Policies and Procedures.

Section 1. General.

1. The official version of the current USEF Licensed Officials Policies and Procedures shall be maintained by the USEF Licensed Officials Department. Only the Policies and Procedures maintained by the USEF Licensed Officials Department will be considered the current and enforceable version.
 - a. The Licensed Officials Policies and Procedures will indicate the version number (i.e. v.1.0) and the date of amendment.
 - b. The Licensed Officials Policies and Procedures shall be published on the USEF website under the Licensed Officials tab.
2. The USEF Licensed Officials Committee shall be responsible for maintaining and amending the Licensed Officials Policies and Procedures subject to the provisions of Section 2.

Section 2. Amendments and Revisions.

1. The USEF Licensed Officials Committee may, from time to time, amend or revise the policies and procedures set forth in the USEF Licensed Officials Policies and Procedures.
2. Amendments and revisions to the Licensed Officials Policies and Procedures may be made annually, except in extraordinary circumstances, as determined by the Licensed Officials Committee, where a revision must occur outside of the Annual Amendment and Revision Process outlined in Section 2, subsection 3.
3. Annual Amendment and Revision Process.
 - a. Beginning on or about ~~September~~ **July 1** of each year, the Licensed Officials Committee will accept recommendations from USEF Committees and Recognized Affiliates for revisions to the Licensed Officials Policies and Procedures.
 - i. USEF Committees and Recognized Affiliates shall submit proposed amendments and revisions to the Licensed Officials Department in a form provided by the Department.
 - b. ~~Prior to the completion of the January Licensed Officials Committee meeting,~~ The **Licensed Official** Committee will review proposed amendments and revisions to Licensed Officials Policies and Procedures and make a recommendation as to approval of the amendments or revisions to the Board.
 - i. Recommendations for amendments and revisions shall be submitted to the Councils and applicable Recognized Affiliate(s) for comment and feedback prior to submission to the Board.
 - ii. ~~Acceptance of amendments and revisions is subject to Federation approval consistent with applicable policies.~~
 - c. ~~Within 14 days of the January Licensed Officials Committee meeting,~~ The **Federation Committee** will publish an updated version of the Licensed Officials Policies and Procedures **on or around December 1**.
 - i. ~~The **Any updates to the** Licensed Officials Policies and Procedures is **will be** effective upon publication.~~
 - ii. Current or pending applicants will be subject to the Licensed Officials Policies and Procedures in effect at the time of the applicant's application to the Federation or entry into a Recognized Affiliate's education program.
 - iii. Amendments and revisions to the Licensed Officials Policies and Procedures shall not be applied retroactively to an applicant, except where the retroactive application would benefit the applicant (e.g. expedited review, reduction of apprenticing requirements, etc.).
 1. An applicant may petition the Director of Licensed Officials in writing for retroactive application of the Licensed Officials Policies and Procedures if ~~s/he~~ believes that retroactive application ~~was~~ **is** warranted, but not initially applied.
4. Changes to the process outlined in this Section are subject to Board approval.

Section 3. Fees. ~~(previously GR1005 Fees)~~

1. Judges, Stewards, Technical Delegates, and Course Designers:
 - a. Initial application or re-enrollment (one division): \$125. Each additional division (limit of three): \$30.
 - b. Application for promotion, including promotion to FEI status: \$50 per division.
 - c. Hunter & Jumper Course Designer's Apprentice Program: \$60.
2. Annual renewal: ~~\$40 per national level licenses. FEI officials: \$35 each person.~~
 - a. **2019 Fee: \$40 per national level licenses. FEI officials: \$35 each person.**
 - b. **2020 Fee: \$40 per license (FEI and national licenses)**
3. Officials' liability insurance: ~~\$15.~~
 - a. **2019 Fee: \$15**
 - b. **2020 Fee: \$20**
4. Special Judge, Steward, Jumper Course Designer, or Hunter Course Designer card: \$55.
5. Guest cards for Judges, Driving Technical Delegates or Combined Driving Course Designers: \$55.

7. Apprentice Permit (HU, HE, HB, JP) application fee: \$60.
8. All fees are non-refundable.

Section 4. Licensing – General. ~~(previously GR1043 General)~~

1. Applications must be made on the appropriate official enrollment or promotion form, signed by the applicant, and accompanied by the required fee which is not refundable.
2. Enrollment or promotion as a judge in more than four divisions at any one time will not be considered.
3. ~~It is the responsibility of the licensed official to accomplish all necessary requirements for maintaining their license. The Federation is not required to provide notices of time periods within which requirements must be fulfilled.~~
4. ~~Documented attendance of an FEI recognized course will count towards fulfilling the clinic requirement of the comparable national discipline judge, course designer, or technical delegate license (Exception: Jumper Judge and Dressage divisions. Dressage judge refer to GR1050.3b), providing it occurs during the same time frame required by the national license.~~
5. ~~The Licensed Officials Committee, not the applicant, will send out any required evaluations concerning the applicant. No member of the Licensed Officials Committee may serve as a reference for an applicant for a judge's, steward's or technical delegate's license. All evaluations must be returned to the Committee.~~
6. If an application is denied, the applicant is not eligible to reapply for the same division until 12 months after the **applicant has been notified of the Federation's** decision. Denied refers to ~~applicant's applications~~ **applications** that have been closed by the Licensed Officials Committee rather than those tabled and asked to complete additional requirements.
7. ~~Anyone~~ **Any applicant who has been** denied for the same license level and type more than three times may not apply again for the same license and type for seven years.
8. ~~Officials who do not pass the examination on their first attempt will have the opportunity to re-take the exam one additional time. If an official does not achieve a passing score on the make-up exam, they are~~

ineligible to renew the license. They may take the comparable exam in the next competition year and if a passing score is achieved, submit a request for reinstatement of that license.

9. The Committee may require a person of any age to pass a physical examination before considering an application for enrollment, promotion, or renewal. The Committee will not reject for physical reasons any application for enrollment, promotion, or renewal before a physical examination has been conducted.
10. For the purposes of maintaining officiating requirements, the first full year after an official's approval will be considered as the start of their officiating record.
11. Unless stated otherwise, all persons, when first approved as a judge in a division, shall receive Recorded status regardless of age or experience unless the applicant holds Registered status with Equestrian Canada or status with the FEI, or another National Federation.
12. All persons when first approved as stewards shall receive a Recorded Category 1, **or** Category 2 license., ~~or Combined Category status regardless of age or experience.~~
 - a. If the applicant is licensed as a Senior or Senior National Steward by Equestrian Canada, the ~~Licensed Officials Committee~~ **Federation** has the option to grant either Recorded or Registered status. The following ~~conditions~~ **requirements** must be met by **Equestrian Canada** Stewards **who are applying for a Federation Steward license**:
 1. ~~USEF~~ **Attend a Federation** Steward's clinic ~~must be attended~~ within two years prior to application for ~~USEF status~~ **Federation licensure**.
 2. Upon receipt of the completed application, a written exam will be mailed to the applicant, with 30 days allowed for return. **Applicants must receive a** passing score **of 85% or higher**.
 3. Verification of Equestrian Canada status must be provided.
 4. USEF Clinic, exam, and officiating requirements to maintain the license apply.
13. All persons when first approved as Vaulting Technical Delegates shall receive Recorded ('r') status. (~~Exception: initial grandfather process which will allow either Recorded 'r' or Registered 'R' status at the discretion of the Licensed Officials Committee.~~)
14. **Application Requirements**
 - a. **All national level and Federation FEI officials must be Competing Active Members, 21 years of age or over. Apprentices must be 21 years of age or over. Exception: Federation judges in the Paso Fino Division must be at least 25 years of age.**
 - b. **All applicants must be compliant with the USEF's Safe Sport Policy before starting any application requirements. In order to be compliant with the policy, applicants must complete Safe Sport Training and a criminal background check.**
15. Renewal, Reinstatement, Re-enrollment, and Re-application of Licenses
 - a. An official who is eligible to renew (up-to-date on clinic, exam, and officiating requirements) ~~his/her~~ license will have one full competition year after the lapse of their license(s), to renew **their license** ~~by the standard procedure; i.e. hard copy renewal or the online renewal.~~
 - b. If two competition years have passed since an official ~~has~~ renewed his/~~her~~ license(s), they must request a reinstatement of licensing. A request for reinstatement must be submitted to the Licensed Officials Department. All first time requests are decided by a ~~Licensed Official Committee Co-Chair~~ **the Licensed Official Committee Chair**. If an Official has received a reinstatement for a specific license in the past, it must be reviewed by the Licensed Officials Committee.
 - c. If three ~~but less than five~~ **or four** competition years have lapsed since an official has renewed his/~~her~~ license(s), **then** they must ~~then~~ apply for re-enrollment of those licenses, following the specific requirements outlined for each license.
 - d. If five or more competition years have lapsed since an official ~~has~~ renewed his/~~her~~ license(s), **then** they must ~~then~~ re-apply for licensing, ~~following~~ **and follow** the full **current** license **application** requirements specified for each license.
16. For any license, the relevant USEF committee or Recognized Affiliate may ~~require that the committee and/or Recognized Affiliate~~ be provided the opportunity to submit an evaluation and recommendation of an applicant as part of the application for licensure. ~~Any such requirement will be stated in the requirements section of the applicable license(s).~~
17. An Apprentice Judge must obtain permissions from the Licensed Competition first followed by approval by the licensed official with whom he will be apprenticing.

18. **Applicants may not start application requirements for a Registered or Senior license before they obtain a recorded or Registered license, respectively.**
19. **If an applicant incurs extreme hardship when attempting to achieve a Recognized Affiliate's license, and if the Recognized Affiliate's license is a requirement for a Federation license, the applicant may request a waiver of the license requirement in writing to the Federation.**
20. **Applicants may submit an appeal regarding a recommendation from an Affiliate and/or USEF Committee to the Federation.**

Section 5. ~~Clinic and Officiating~~ Maintenance Requirements. (previously GR1044 Clinic and Officiating Requirements)

1. **It is the responsibility of the licensed official to satisfy all necessary requirements for maintaining their license. The Federation is not required to provide notices of time periods within which requirements must be fulfilled.**
2. **Documented attendance of an FEI recognized course will count towards fulfilling the clinic requirement of the comparable national discipline judge, course designer, or technical delegate license (Exception: Jumper Judge and Dressage divisions. Dressage judge refer to Chapter Two, Section 6), provided it occurs during the same time frame required by the national license.**
3. **Officials who do not pass a maintenance examination on their first attempt will have the opportunity to re-take the exam one additional time. If an official does not achieve a passing score on the make-up exam, they are ineligible to renew the license. They may take the comparable exam in the next competition year and if a passing score is achieved, submit a request for reinstatement of that license.**
4. **A one-year clinic extension with or without officiating restrictions ~~or~~, a one-year officiating extension, **or one-year measurement extension** may be granted.**
 - a. **All first time requests are decided by a ~~the~~ Licensed Official Committee ~~Chair~~.**
 - b. **If an official has received the respective clinic, officiating, or measurement extension in the past, it must be reviewed by the Licensed Officials Committee.**
 - c. **If the Licensed Officials Committee reviews ~~the~~ a clinic extension request, officiating restrictions may be given.**
 - d. **All requests must be received in writing via mail, email, or fax **on the appropriate form provided on the Federation website.****
5. **In the event that an official's clinic requirement falls due in a year in which a corresponding clinic is not offered, the deadline will automatically be extended to the following year with no restriction, provided ~~ing~~ all other requirements of the license are met.**
6. **Documented adjudication of FEI recognized classes at foreign FEI sanctioned competitions will count towards maintaining the same national discipline judge or course designer license, provided ~~ing~~ it occurs during the same time frame required by the national license.**
7. **~~Refer to the specific breed/discipline rules in Subchapter 10-I of this Chapter for specific officiating and exam requirements.~~**
8. **Verified judging of an Equestrian Canada competition will be considered a suitable substitute for a Federation competition for the purposes of maintaining a current license but not for enrollment or promotion apprentice requirements. Written verification must be submitted to the Federation to substantiate EC officiating. Any requests for acceptance of officiating experience in countries other than Canada will be considered on an individual basis.**
9. **The Licensed Officials Committee can require an official to complete additional educational experience.**

Chapter 2. Policies and Procedures for Breed/Discipline Licenses.

Section 1. Andalusian/Lusitano Judges. (previously GR1045 Andalusian/Lusitano Judges)

Section 1.1 Requirements to Obtain 'r' Status

- A. Eligibility Requirements
 1. **Applicants are not required to meet any additional eligibility requirements besides those defined in Chapter 10 of the Federation rulebook and/or the Licensed Official Policies and Procedures.**
- B. Application Requirements

1. **Applicants may complete the following requirements in any order. However, the final examination must be completed last.**
2. Apprentice judge at a minimum of two different Federation Licensed Competitions, under **a minimum of two different Registered ('R') Federation Andalusian/Lusitano judges within three years preceding license application.** These requirements must be fulfilled within a three-year period preceding application. **The applicant must apprentice all Federation Andalusian/Lusitano classes offered at the competition. The applicant must receive at least two positive apprentice evaluations. If the applicant fails to receive a positive apprentice evaluation from the judges, the applicant may continue to apprentice with Federation Registered ('R') Andalusian/Lusitano judge(s) at Federation Licensed Andalusian/Lusitano competitions until they receive two positive apprentice evaluations.**
 - i. **Exception: The apprenticeship requirement is not required for Registered ('R') judges licensed in the Arabian, Morgan, Friesian, or Welsh divisions.**
3. All persons applying for enrollment or re-enrollment must have Attended a Federation/~~IALHA~~**Andalusian/Lusitano judges' clinic within three years preceding license application.**
4. **Applicants must and receive a passing score of 85% or better higher on an the Federation Andalusian/Lusitano final examination within five years preceding license application.** administered by the Federation within three years preceding application. **If the applicant fails the test on the first attempt, they may re-take the exam one additional time. If a passing score is not achieved on the second attempt, the applicant must repeat all application requirements.**

C. Maintenance Requirements

1. Judges must attend a Federation/~~IALHA~~**Andalusian/Lusitano judges' clinic every five years.**
2. **Judges must and receive a passing score of 85% or better higher on an examination administered by the Federation every two years.**

Section 1.2 Requirements to Obtain 'R' Status

A. Eligibility Requirements

1. **Applicants are not required to meet any additional eligibility requirements besides those defined in Chapter 10 of the Federation rulebook and/or the Licensed Official Policies and Procedures.**

B. Application Requirements

1. **Applicants must complete the application requirements in the order defined below.**
2. **Applicants must officiate in at least two Federation Andalusian/Lusitano licensed competitions in the past three years.**
3. **Applicants must complete a final examination with a score of 85% or higher.**
4. ~~No applicant will be considered for promotion unless he has adjudicated Andalusian/Lusitano divisions in at least two Licensed Competitions during the past three years, verified by stewards' reports.~~

C. Maintenance Requirements

1. **Judges must attend a Federation/Andalusian/Lusitano judges' clinic every five years.**
2. **Judges must receive a passing score of 85% or higher on an examination administered by the Federation every two years.**

Section 2. Arabian Judges. (previously GR1046 Arabian Judges)

Section 2.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the Arabian Horse Association (AHA) for three consecutive years prior to evaluation and testing.**

B. Application Requirements

1. **Applicants may complete the following requirements in any order. However, the AHA Evaluation must be completed last.**
2. Applicants for enrollment will not be considered unless the applicant has **must** attended **all sessions of the Federation/AHA Exhibitors/Judges' School**, and successfully passed all phases of an examination at this School within one year preceding application. **Apprenticeships may be completed prior to attendance at School. However, wherever possible, apprenticeships should be completed after attending the School.**

3. Applicants for enrollment will not be considered unless the applicant served as an **must** apprentice Judge at a minimum of three **Federation** licensed competitions in the Arabian division, under a minimum of three different Federation/AHA Registered Arabian judges within a three-year period preceding application. **The 'R' judge is required to discuss the evaluation with the apprentice and provide the apprentice with a copy of the entire evaluation form. Evaluation forms must also be submitted to USEF and AHA.** A copy of the Apprentice Judge Evaluation Form shall be submitted to the Federation and to AHA.
4. **Applicants must pass each of the following components of the AHA Evaluation within one year preceding application to USEF:**
 - i. **AHA-administered written examinations;**
 1. **Passing scores vary from 80-85% depending on the exam.**
 - ii. **Video testing**
 1. **Video testing is scored using the same method as the majority of horse/livestock judging contests.**
 - iii. **Live Judging of in-hand and performance classes;**
 1. **Live judging is scored using the same method as the majority of horse/livestock judging contests.**
 - iv. **AHA administered interviews conducted by EEC members and others as appointed by the Commissioner.**
 1. **A standard evaluation form with scoring rubric is utilized. Passing score is overall 4 out of 5 points.**

C. Maintenance Requirements

1. All Arabian Judges must attend and successfully complete all requirements of a **all sessions of the Federation/AHA Judges' Seminar at least once every three years, by seminar or other means of education as determined by the AHA Education/Evaluation Commission or the AHA Judges and Stewards Commissioner's Office.** At the request of the USEF Licensed Officials Committee (LOC), the Education Evaluation Commission (EEC), or the AHA Judges and Stewards Commissioner's office, A judge may be required **by the LOC** to attend a Seminar outside of his regular rotation.
2. All Judges must satisfactorily complete **pass** a written exam **with a score of 85% or higher** once every three years with a minimum score of 85%; National/Regional judges must earn a score of 90% to maintain N/R status with AHA.

Section 2.2 Requirements to Obtain 'R' Status

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the AHA.**

B. Application Requirements

1. **Applicants must complete the application requirements in the order defined below.**
2. **Applicants must attend a Federation/AHA Judges' Seminar.**
3. **Officiate five days (six hours minimum each day) at a minimum of two Federation licensed competitions with an Arabian division within the past four years. At least one of the Federation licensed competitions must be outside of the applicant's home AHA Region. Applicants must judge a minimum of 440 horses during the past six years at Federation licensed and/or AHA recognized Arabian competitions/divisions in the following classes/sections. Classes judged at USEF as well as AHA One Day Shows and AHA Value Shows count equally in meeting these officiating requirements. (The number of horses shown as listed in official results for a class equal number of entries in that class.)**

If the applicant holds any of the following licenses, the individual may submit a request to AHA for certain requirements as listed within this document to count towards partial fulfillment of promotion requirements. All officiating must be verified either through Federation competition records or the non-USEF affiliated breed/discipline records.

- ***Federation Recognized Affiliate breed or discipline license***
 - ***NRHA license***
 - ***Non-USEF affiliated breed/discipline (example AQHA, Paint, Pinto)***
- 4. *Submit a Request for Recommendation for Promotion application to the AHA Judges & Stewards Commissioner.***
- i. Submit the application to AHA a minimum of six weeks prior to the USEF deadline for applications.***
 - ii. Include the application fee of \$50***
 - iii. Provide the names and email address of at least five but no more than 10 current USEF Arabian judges, Equestrian Canada Arabian judges, AHA Arabian division judges, and/or Category 2 stewards for references.***
 - iv. The Judges and Stewards Commissioner may solicit evaluations from competition managers regarding the applicant's officiating and conduct.***
 - 1. After evaluations have been returned from the references, and after officiating requirements have been verified, the Education and Evaluation Commission (EEC) will make a recommendation to the Judges & Stewards Commissioner regarding the promotion request. The Judges & Stewards Commissioner will inform the 'r' judge and USEF, in writing, of the AHA decision.***
 - v. Applicants must receive a positive recommendation from AHA.***
- 5. *Applicants must pass a final examination with a score of 85% or higher.***

- ~~7. No applicant will be considered for promotion unless he has adjudicated in at least two Licensed Competitions with an Arabian Division, with a total of five (5) days judging (6 hour minimum each day) during the past four years in the division in which he is applying, verified by stewards' reports.~~
- C. *Maintenance Requirements***
- 1. Judges must attend the Federation/AHA Judges' Seminar every three years.***
 - 2. Judges must pass a written examination with a score of 85% or higher every three years.***

Section 3. Carriage Pleasure Driving

Section 3.1 – Judges. ~~(previously GR1047 Carriage Pleasure Driving Judges)~~

Section 3.1.1 Requirements to Obtain 'r' Status

- A. *Eligibility Requirements***
 - 1. Applicants for enrollment will not be considered unless they are currently licensed by the American Driving Society, and shall.***
- B. *Application Requirements***
 - 1. Applicants may complete the following requirements in any order. However, the final examination must be completed last.***
 - 2. Have Apprenticed at least one Federation licensed Carriage Pleasure Driving, Breed, or Multi-breed Competition with either breed-restricted and/or open Carriage Pleasure Driving classes and receive a positive evaluation from the officiating Federation Carriage Pleasure Driving judge.***
 - 3. Have successfully Completed a Federation Carriage Pleasure Driving judge's written exam and received a score of 85% or better higher.***

4. ~~Have completed~~ **Attend** a Federation approved ADS Pleasure Driving officials' clinic.
5. ~~For an~~ **if an** applicant in the Carriage Pleasure Driving Division who already holds Registered status with the American Driving Society, the Licensed Officials Committee shall have the option of granting Federation Registered status.

C. Maintenance Requirements

1. ~~The Licensed Officials Committee will require~~ Judges who do not **must** officiate at one ~~USEF~~ **Federation** licensed competition with Carriage Pleasure Driving classes or ADS recognized Pleasure Driving Competition with 16 classes or more within five years after obtaining a license or for any five-year period thereafter, ~~to re-apply for a license.~~
2. All Carriage Pleasure Driving Judges must attend a Federation/ADS Carriage Pleasure Driving Judges' clinic, and receive a score of 85% or ~~better~~ **higher** on judges' written examination ~~at least once~~ every three years.

Section 6.2.1 Requirements to Obtain ‘r’ Status

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the USDF.**
2. **All applicants must demonstrate knowledge and experience with the breeding of horses raised primarily for dressage for a minimum of five years. This may include experience as a breeding manager, owner, breeder or trainer of sport horses showing in Dressage Sport Horse Breeding (DSHB) classes, or member of an inspection jury of a WBFSH breed association**
3. **All applicants must fulfill two of following (either iv or v can be counted, but not both):**
 - i. **Be a Federation licensed Dressage Judge**
 - ii. **Have judged USEF/USDF DSHB classes totaling at least 16 hours, including in hand, group and under saddle or materiale classes. Classes must be at USEF/USDF licensed Dressage Competitions holding DSHB classes.**
 - iii. **Have exhibited as a breeding manager, owner, breeder, or trainer in DSHB classes at USEF/USDF licensed Dressage Competitions in Sport Horse Prospect or Breeding Stock in-hand classes, receiving a minimum of four scores at 70% or higher, from a minimum of three different judges. Group or Individual Breed Classes (IBC) will not be considered.**
 - iv. **Either, have owned, bred or trained at least two horses which have shown successfully in DSHB classes at USEF/USDF licensed Dressage Competitions resulting in placing in the top 25% of USDF DSHB Horse of the Year (HOY) awards or qualifying for a USDF Breeders Championship Series Finals with a minimum score of 70%;**
 - v. **Have bred at least two horses which have qualified under saddle for USEF/USDF Dressage Regional Championships at any level and division per published minimum requirements.**

- vi. *Participate as a member of the Inspection Jury for a European breed association or its North American affiliate at a minimum of three inspection sites with a minimum of ten horses inspected at each site.*

B. Application Requirements

 - i. *Attend two USDF Sport Horse Clinics within six years preceding application.*

Section 6.3.1 Requirements to Obtain 'r' Status

- A. Eligibility Requirements
- 1. Applicants must be a current member in good standing with the USDF.**
 - 2. The following requirements for enrollment in the 'r' Dressage Technical Delegates Training Program must be completed within eight years of the training program application date:**
 - i. Serve as an active member of the organization committee at five or more Federation licensed Dressage Competitions.**
 - 1. This service should include participation as the qualified manager or qualified secretary (including either entry and/or competition secretary positions) of at least two competitions with responsibility for the respective duties that are outlined in USEF Chapter 12. The applicant must have been on the grounds throughout the two competitions.**
 - 2. At least two of the five competitions must have separate competition recognition numbers, and be two or more days in length**
 - a. At least two competitions must be at separate locations.**
 - b. At least four of these competitions must be Level 2 or higher.**
 - 3. Must be qualified for the manager and secretary positions according to USEF Dressage Levels criteria, and must be the manager or secretary of record with USEF and USDF.**
 - ii. Serve for a minimum of five full days, one each at a minimum of three different Federation licensed Dressage Competitions operated under at least three different managers and three different Licensees.**
 - 1. At least one day of secretarial work and one day of scoring, including freestyles, is required.**
 - 2. For the remaining three days, serve in three or more of the following positions: scribe, scorer, stable manager, grounds manager, chief ring steward, volunteer coordinator or a similar position of responsibility.**

3. *A full day is a minimum of six working hours at competition. Working less than six hours per day cannot be used to fulfill this requirement but may be used as additional experience.*
 3. *One of the following is also required along with appropriate documentation:*
 - i. *Experience at three different Federation Dressage Competitions as a competitor, trainer, or coach.*
 - ii. *Participation as part of management or as a competitor at five separate non-USEF licensed/USDF-recognized Dressage Competitions that may include USEF licensed Regular Competitions, USDF Jr/YR or Adult Team competitions, schooling or Pony Club dressage competitions.*
 4. *Exception: 'R' Category 2 (C2) Stewards who have been licensed by the Federation for a minimum of five years, and who have officiated at a minimum of five Federation licensed Regular Competitions holding Dressage classes, may apply for enrollment in the recorded ('r') Dressage Technical Delegate Training Program upon completion of at least three full days service in two or more of the following positions at a Dressage Competition: manager, secretary, or scorer.*
 5. *Applicants must complete and submit the Documentation of Experience form for all of the above experiences.*
- B. Application Requirements
1. *Applicants to become a Dressage Technical Delegate must complete the current training program of the Federation Dressage Committee. The program must also be approved by the Federation Licensed Officials Committee. Information on the application procedure and on the current program is available from the Federation office.*
 2. *Applicants must complete the application requirements in the order defined below. Any exceptions will be noted below. The application requirements must be completed within two years of the application date.*
 3. *Submit training program application to USDF.*
 4. *Attend a Federation Measurement Certification clinic at any time before the Final Examination.*
 - i. *Federation Dressage/Federation approved USDF/DSHB Pony Measurement Certification clinics must include a live measurement evaluation (including a practical and written examination), which must be passed with a minimum score in each section of 75% or better ~~higher~~ **higher (written and practical)**. In addition, in order to obtain a passing score in the practical examination, the person being evaluated must receive scores of "5" or above in every category.*
 5. *Attend a USDF Apprentice TD program and a USDF Dressage TD clinic within one calendar year of acceptance into the training program and prior to any apprenticing.*
 6. *Apprenticeship*
 - i. *Applicants must apprentice at a minimum of four different Federation licensed Dressage Competitions:*
 1. *Apprentice with at least three different Federation licensed Dressage Technical Delegates who are on the approved mentor list. Two of the presiding TD's must be Registered (R) DTDs.*
 2. *Three of the competitions must be longer than one day.*
 3. *Three of the four competitions must offer FEI level classes.*
 4. *The competitions must be in at least two different locations, at least one of which must be with a Federation approved 'R' DTD in a location outside the apprentice's home USDF Region and one in a location outside of the apprentice's home state.*
 - ii. *Multiple competitions held on consecutive days under the same Management and Licensee will be counted as one competition for the purpose of apprenticing. In order for an apprenticeship to be counted the apprentice must attend the entire competition and perform no other activities related to the competition (i.e. competing, management).*
 - iii. *All apprenticeships must be completed with DTDs who accept apprentices and must be approved by the Federation to accept apprentices. Apprenticeships with DTDs who are not on an approved list will not be counted towards the minimum number required for the DTD training program.*

7. **Final Examination**

- i. **Complete a written examination that consists of 60% closed book and 40% open book, which will be administered each year at the USDF Annual Convention, before or after the annual Dressage TD clinic, or at another time and location approved and supervised by the USEF Licensed Officials Department. Applicants must receive an overall score of 80% or better score on the exam.**

4. **Pass a written examination with a mark of 84% or better, administered at a Federation/USHJA Hunter/Jumping Seat Equitation Judges Clinic.**
5. **Apprenticeships**
 - i. **Apprenticing must be completed within 24 months preceding license application.**
 1. **Apprentice with at least five different Federation Registered (R) Judges.**
 2. **Apprentice at least 15 hunter/jumping seat equitation classes total from the following list: USEF Hunter Seat Medal, WIHS, Talent Search, Maclay, NCEA Medal, USHJA 3'3" Jumping Seat Medal, USEF Pony Medal, WIHS Pony and Age Group equitation.**
 - a. **Three of the 15 classes must be flat classes or have a flat portion.**
 - b. **Five of the 15 classes must be medal classes from the following list: USEF Hunter Seat Medal, WIHS, Talent Search, Maclay, NCEA Medal, USHJA 3'3" Jumping Seat Medal, USEF Pony Medal, and WIHS Pony.**
 3. **Apprenticeships must be completed at three Federation National or Premier licensed Competitions in three different locations.**
 4. **If equitation classes are in different rings, the apprentice judge may switch rings to fulfill requirements, but must return to their original instructor judge after the class(es) has/have finished to complete the day.**
 - ii. **Apprentices must receive positive evaluations from a majority of the judges that they apprentice with. Apprentices who do not meet this requirement must apprentice with and receive a positive evaluation from a judge from the "Teaching Judges" list. Failure to receive a majority of positive recommendations will result in the applicant failing to move forward to licensure.**

2. **Attend a Federation/USHJA Hunter & Hunter/Jumping Seat Equitation clinic within 24 months preceding Mentor Permit application.**
3. **Pass a written examination with a mark of 70% or better, administered at the Federation/USHJA Hunter/Jumper Equitation judges' clinic. Pass a practical examination with a mark of 70% or better, administered at the Federation/USHJA Hunter/Jumping Seat Equitation judges' clinic.**
4. **Request approval from a mentor from the Federation Mentor list and submit Mentor Permit Application to the Federation. Applicants may begin Apprenticing after receiving notification that the License Officials Department has approved Mentor Permit Application.**

 - i. **The following requirements must be completed within 24 months preceding application for enrollment:**
 1. **Apprentice at three Federation National or Premier licensed competitions. The competitions must be held at a minimum of two different locations.**

Section 10.3.1 Requirements to Obtain 'r' Status

- 2. Applicants must have verifiable experience designing hunter/equitation courses at Federation licensed Regional I, Regional II, Local competitions, or USHJA Outreach competitions.**

B. Application Requirements

1. **Applicants must complete the application requirements in the order defined below.**
2. **Attend a Federation/USHJA Hunter Course Designer clinic within 24 months preceding the permit application.**
3. **Pass a written examination with a score of 84% or better administered at the Federation/USHJA Hunter Course Designer Clinic.**
4. **Apply to the Licensed Officials Department for an Apprentice Permit. Applicants may begin Apprenticing after receiving notification that the License Officials Department has approved Apprentice Permit.**
5. **Apprenticeships**
 - i. **Apprenticing must be completed within 24 months preceding license application.**
 1. **Apprentice with three different Federation Registered ('R') Hunter Course Designers**
 2. **Apprentice 12 full days at a minimum of three Federation licensed National or Premier Competitions in different locations.**
 - ii. **Apprentice the following classes within the three or four required competitions:**
 1. **One USHJA National Hunter Derby**
 2. **Three Hunter/Jumping Seat Equitation Classes from the following list: USEF Hunter Seat Medal, WIHS, Talent Search, Maclay, NCEA Medal, USHJA 3'3" Jumping Seat Medal, USEF Pony Medal, WIHS Pony, and Age Group equitation.**
 - iii. **Apprentices must receive positive evaluations from a majority of the Course Designers that they apprentice with. Apprentices who do not meet this requirement must apprentice with and receive a positive evaluation from a Course Designer from the "Teaching Course Designers" list. Failure to receive a majority of positive recommendations will result in the applicant failing to move forward to licensure.**
6. Applicants must complete the current requirements of the respective license and type for which they are applying. Information on application procedure and the current programs are available from the Federation and are located on the Federation website.
7. All applicants and licensed Hunter, Hunter/Jumping Seat Equitation Course Designers must be an Active member in good standing of the United States Hunter Jumper Association, Inc.

C. Maintenance Requirements

1. To maintain his/her license, an 'r' Recorded Hunter Course Designers must attend a Federation/USHJA Hunter Course Designer clinic at least once every three years and a 'R' Registered Hunter Course Designer must attend a Federation/USHJA Hunter Course Designer's Clinic at least once every five years.
2. **Course Designers must pass a written exam with a score of 84% or higher every three years.**
3. 'r' Recorded Hunter Course Designers will be required to **must** officiate at six **Federation** licensed competitions every three years in order to renew their license. 'R' Registered Hunter Course Designers will be required to officiate at nine licensed competitions every three years in order to renew their license. This is a rolling schedule and the three years resets each December 1st (the beginning of the USEF competition year.) 4. **Apprenticeships**
 - i. **Apprentice at minimum of two Federation licensed competitions with at least two different Federation Registered (R) Hunter Judges with a Hunter Breeding License.**

- ii. **Earn at least 10 points, one point for every horse judged.**
 - 1. **Hunter Breeding classes with only three or more horses will count towards points.**
 - 2. **Applicants may substitute with one pony breeding section with at least three in the class. If apprenticing a pony breeding section, only five of the 10 required points may be earned from the pony breeding section.**
- iii. **Exceptions:**
 - 1. **Recorded (r) Hunter Judges with a minimum of five years of officiating experience may apply after apprenticing two complete Hunter Breeding sections at two Federation Licensed Competitions with two different Hunter Judges with Hunter Breeding Licenses.**

A. Eligibility Requirements

1. ***Applicants must be a current member in good standing with the United States Hunter Jumper Association (USHJA).***
2. ***Applicants must have been an active competitor as either a rider, trainer, coach, or official in the Jumper Division at Federation licensed competitions within the last four years.***

B. Application Requirements

1. ***Applicants must complete the application requirements in the order defined below.***
2. ***Attend a Federation/USHJA Jumper Judge clinic within 24 months preceding the Permit application.***
3. ***Pass a written examination with a mark of 85% or better, administered at the Federation/USHJA Jumper Judges Clinic.***
4. ***Apply to the Licensed Officials Department for an Apprentice Permit. Applicants may begin Apprenticing after receiving notification that the Licensed Officials Department has approved the Apprentice Permit.***

- i. ***Exception: Apprentice permits are not required if the applicant is already licensed in the Hunter or Hunter/Jumping Seat Equitation divisions. However, applicants must have attended a clinic within 24 months preceding their first apprenticing experience.***

Apprentice Judge forty classes including four full days in the Jumper Division with a minimum of two different Federation Registered Jumper judge at a minimum of four Federation Licensed Competitions offering \$2,500 or more in prize money in their Jumper Division. b. The***

Apprentice Judge must have no other duties or responsibilities at the competition where he/she is fulfilling his/ her requirements. c. Apprentice Judges must demonstrate to the Registered Jumper Judge their ability to keep a jumper scorecard and also to operate the timing equipment. d. These requirements must be fulfilled within a three-year period preceding application.

C. Maintenance Requirements

1. Recorded (“r”) jumper Judges must attend a Federation/USHJA Jumper Clinic at least once every three years.
2. A Recorded (r) Jumper Judges must take **pass** a written examination **with a score of 85% or higher** every **two three** years and receive a mark of 85% or better before his/her license can be renewed.
3. The Committee will require Judges who do not **must** officiate at one **Federation** licensed competition **within every** three years in the Jumper division after obtaining a license to apply for an officiating extension.

Section 12.1.2 Requirements to Obtain ‘R’ Status

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the USHJA.**
2. **Applicants must have maintained a ‘r’ Jumper license for 36 months before applying for a promotion.**

B. Application Requirements

1. **Applicants must complete the application requirements in the order defined below.**
2. **Applicants must officiate for at least two or more Federation licensed Rating 3 or higher competitions in the Jumper Division within the past three years.**
3. **Applicants must attend a Federation/USHJA Jumper Judge Clinic within 24 months preceding license application.**
4. **Applicants must pass a written examination with a score of 85% or better, administered at the Federation/USHJA Jumper Judges Clinic.**
5. **Apprenticeships**
 - i. **Apprenticing must be completed within 24 months preceding license application.**
 - ii. **Apprentice with at least five different Federation Registered (R) Jumper Judges.**
 - iii. **Apprentice 12 days at a minimum of three Federation licensed Level 4 or higher competitions in different locations.**
 - iv. **Apprentices must receive positive evaluations from a majority of the judges that they apprentice with. Apprentices who do not meet this requirement must apprentice with and receive a positive evaluation from a judge from the “Teaching Judges” list. Failure to receive a majority of positive recommendations will result in the applicant failing to move forward to licensure.**

C. Maintenance Requirements

1. Registered (“R”) jumper Judges must attend a Federation/USHJA Jumper Clinic at least once every five years.
2. A Registered (R) Jumper Judges must take **pass** a written examination **with a score of 85% or higher** every four **five** years and receive a mark of 85% or better before his/her license can be renewed.
3. **Judges must officiate one Federation licensed competition every three years.**
4. ~~No applicant will be considered for promotion unless he has adjudicated in at least two Licensed Competitions during the past three years in the Jumper division, verified by stewards’ reports.~~
4. ~~All persons applying for enrollment, re-enrollment or promotion must have attended a Federation/USHJA judges’ clinic within two years preceding application. Persons applying for enrollment must also pass a written examination, administered in conjunction with the Clinic, with a mark of 85% or better.~~
5. ~~Registered (R) Jumper Judges that have held ‘R’ status over 20 years, upon 2/3 vote of the National Jumper Committee at a properly noticed meeting, may receive the title “Master.” The person may only be nominated for this “Masters” status by at least three currently sitting members of the National Jumper Committee.~~
6. ~~Foreign FEI Jumper Judges may apply to the Licensed Officials Department for a Federation Registered Jumper Judge card by fulfilling the following requirements: a. Attend a Federation/USHJA Jumper~~

Judges' Clinic, b. Successfully complete the Jumper Judges written exam with a score of 85% or higher, and c. Obtain approval from the National Jumper Committee.

7. Any judge officiating Federation Open (not restricted to a breed) hunter and/or jumper classes must be a current member in good standing of the United States Hunter Jumper Association, Inc.

Section 12.2 – Course Designer. ~~(previously GR1066 Jumper Course Designer)~~

Section 12.2.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the USHJA.**
2. **Applicants must have verifiable experience designing jumper courses at Federation licensed Rating 1 or higher competitions, Local competitions or USHJA Outreach competitions.**

B. Application Requirements

1. Applicants must complete the current requirements of the respective license and type for which they are applying. Information on application procedure and the current programs are available from the Federation and are located on the Federation website.
2. **Applicants must complete the application requirements in the order defined below.**
3. **Applicants must attend a Federation/USHJA Jumper Course Designer within 24 months preceding permit application.**
4. **Applicants must pass a written examination with a score of 84% or higher, administered at the Federation/USHJA Jumper Course Designer clinic.**
5. **Apply to the Licensed Officials Department for an Apprentice Permit. Applicants may begin Apprenticing after receiving notification that the License Officials Department has approved Apprentice Permit.**
6. **Apprenticeships**
 - i. **Apprenticing must be completed within 24 months preceding license application. The Apprentice Course Designer will work the days required of the Course Designer and will have course work completed for each day of the competition as if that individual were building the rings himself. These courses will be completed each day, will be organized and include build sheets. If possible, Apprentices will have this available for the first day but if not, will be completed for the remaining days of the competition.**
 - ii. **Apprentice with three different Federation Registered Course Designers**
 - iii. **Apprentice 12 full days at a minimum of three Federation license Level 3 or higher competitions at three different locations.**
 - iv. **Apprentices must receive positive evaluations from a majority of the course designers that they apprentice with. Apprentices who do not meet this requirement must apprentice with and receive a positive evaluation from a course designer from the "Teaching Course Designers" list. Failure to receive a majority of positive recommendations will result in the applicant failing to move forward to licensure.**

C. Maintenance Requirements

1. All licensed Course Designers will be required to **must** attend a **Federation/USHJA Jumper** Course Design Clinic (Federation/USHJA or FEI) every three years to maintain their 'r' recorded license or five years to maintain their 'R' Registered license. (Exception – "R" Course Designers who also hold their FEI Jumping Course Designer license must only maintain their clinic requirements as outlined by the FEI).
2. **Course Designers must pass a written exam with a score of 84% or higher every three years.**
3. **Course Designers must officiate at six Federation licensed competitions every three years.**
4. All applicants who hold an Equestrian Canada Jumper Course Design card will be given the same status for The Federation.
5. The following officiating maintenance requirements will be in place: a. 'r' recorded Jumper Course Designers will be required to officiate at six licensed competitions every three years in order to renew their license. b. 'R' Registered Jumper Course Designers will be required to officiate at nine licensed competitions every three years in order to renew their license. c. Individuals currently licensed as an FEI Jumping Course Designer who officiate at a CSI2* or higher outside the United States may include these competitions as part of their Federation officiating maintenance requirements. d. Maintenance requirements are on a rolling schedule. The three years resets each December 1st (the beginning of the

USEF competition year). e. If officiating maintenance requirements are not met, the official may request an officiating extension.

6. Any individual currently licensed by the FEI as 3* or 4* Course Designer for Show Jumping, with approval of the Federation National Jumper Committee, is eligible to become a “R” USEF Course Designer for Show Jumping without having to apprentice, take a clinic, or exam.
7. All applicants and licensed Jumper Course Designers must be an Active member in good standing of the United States Hunter Jumper Association, Inc.

Section 12.2.2 Requirements to Obtain ‘R’ Status

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the USHJA.**
2. **Applicants must have maintained a ‘r’ Jumper Course Design license for 36 months before applying for a promotion.**

B. Application Requirements

1. **Applicants must complete the application requirements in the order defined below.**
2. **Applicants must officiate at three or more Federation licensed Rating 3 or higher competitions.**
3. **Applicants must attend a Federation/USHJA Jumper Course Designer clinic within 24 months preceding application for promotion.**
4. **Applicants must pass a written examination with a score of 84% or higher, administered at the Federation/USHJA Jumper Course Designer clinic.**
5. **Apprenticeships**
 - i. **Apprenticing must be completed within 24 months preceding license application. The Apprentice Course Designer will work the days required of the Course Designer and will have course work completed for each day of the competition as if that individual were building the rings himself. These courses will be completed each day, will be organized and include build sheets. If possible, Apprentices will have this available for the first day but if not, will be completed for the remaining days of the competition.**
 - ii. **Apprentice with three different Federation Registered Jumper Course Designers**
 - iii. **Apprentice 12 full days at a minimum of three Federation licensed Rating 4 or higher competitions at three different locations.**
 - iv. **Apprentices must receive positive evaluations from a majority of the course designers that they apprentice with. Apprentices who do not meet this requirement must apprentice with and receive a positive evaluation from a course designer from the “Teaching Course Designers” list. Failure to receive a majority of positive recommendations will result in the applicant failing to move forward to licensure.**

C. Maintenance Requirements

1. **Course Designers must attend a Federation/USHJA Jumper Course Design clinic every five years.**
2. **Course Designers must pass a written exam with a score of 84% or higher every five years.**
3. **Course Designers must officiate at nine Federation licensed competitions every three years.**

Section 12.2.3 Requirements to Obtain ‘r’ Status – Mentor Program

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the USHJA for a minimum of five years.**
2. **Applicants must not have been suspended by the Federation within five years preceding mentor permit application. Exception: Medical suspensions are permitted.**

B. Application Requirements

1. **Applicants must complete the application requirements in the order defined below.**
2. **Attend a Federation/USHJA Jumper Course Design clinic within 24 months preceding Mentor Permit application.**
3. **Pass a written examination with a mark of 84% or higher, administered at the Federation/USHJA Jumper Course Designer Clinic.**
4. **Request approval from a mentor from the Federation Mentor list and submit Mentor Permit Application to the Federation. Applicants may begin Apprenticing after receiving notification that the License Officials Department has approved Mentor Permit Application.**
5. **Apprenticeships**

- i. ***Apprenticing must be completed within 24 months preceding license application for enrollment.***
- ii. ***Must work with a Mentor Course Designer for a minimum of 10 days at Federation Rating 2-5 Jumper Licensed competitions or at FEI only competitions. These 10 days can be completed at three or four Federation licensed competitions, but preferably not more than four competitions. The apprenticeships must be completed at a minimum of three different venues.***
- iii. ***One of the required competitions must include a minimum of a \$25,000 Grand Prix.***
- iv. ***Apprenticeships may occur at National or International Championships (Prix des States, North American Young Riders and USHJA National Championship)***
- v. ***The Apprentice Course Designer will work the hours required of the Mentor and will have course work completed for each day of the competition as if that individual were building the rings him/herself. These courses will be completed each day, will be organized, and include build sheets. If possible, Apprentices will have this available for the first day but if not, will be completed for the remaining days of the competition.***

C. Maintenance Requirements

1. ***Course Designers must attend a Federation/USHJA Jumper Course Design clinic every three years.***
2. ***Course Designers must pass a written exam with a score of 84% or higher every three years.***
3. ***Course Designers must officiate at six Federation licensed competitions every three years.***

Section 12.2.4 Requirements to Obtain 'R' Status – Mentor Program

A. Eligibility Requirements

1. ***Applicants must be a current member in good standing with the USHJA for a minimum of five years.***
2. ***Applicants must not have been suspended by the Federation within five years preceding mentor application. Exception: Medical suspensions are permitted.***

B. Application Requirements

1. ***Applicants must complete the application requirements in the order defined below.***
2. ***Attend a Federation/USHJA Jumper Course Design clinic within 24 months preceding Mentor Permit Application.***
3. ***Pass a written examination with a mark of 84% or higher, administered at the Federation/USHJA Jumper Course Designer Clinic.***
4. ***Request approval from a mentor from the Federation Mentor list and submit Mentor Permit Application to the Federation. Applicants may begin Apprenticing after receiving notification that the License Officials Department has approved Mentor Permit Application.***
5. ***Apprenticeships***
 - i. ***Apprenticing must be completed within 24 months preceding license application.***
 - ii. ***Must work with a Mentor Course Designer for a minimum of 10 days at Federation Rating 2-5 Jumper Licensed competitions or at FEI only competitions. These 10 days can be completed at three or four Federation licensed competitions, but preferably not more than four competitions. The apprenticeships must be completed at a minimum of three different venues.***
 - iii. ***One of the required competitions must include a minimum of a \$25,000 Grand Prix.***
 - iv. ***Apprenticeships may occur at National or International Championships (Prix des States, North American Youth Championships or USHJA National Championship).***
 - v. ***The Apprentice Course Designer will work the hours required of the Mentor and will have course work completed for each day of the competition as if that individual were building the rings him/herself. These courses will be completed each day, will be organized, and include build sheets. If possible, Apprentices will have this available for the first day but if not, will be completed for the remaining days of the competition.***

C. Maintenance Requirements

4. ***Course Designers must attend a Federation/USHJA Jumper Course Design clinic every five years.***
5. ***Course Designers must pass a written exam with a score of 84% or higher every five years.***
6. ***Course Designers must officiate at nine Federation licensed competitions every three years.***

Section 13. Morgan Judges. (previously GR1068 Morgan Judges)

Section 13.1 Requirements to Obtain 'r' Status

- A. Eligibility Requirements
1. **Applicants must be a current member in good standing with the American Morgan Horse Association (AMHA).**
- B. Application Requirements
1. **Applicants may complete the following requirements in any order.**
 2. All applicants must attend two AMHA judge's schools, every day of the first school and two consecutive days of the second school and serve as an Apprentice Judge in the Morgan division at a minimum of one entire Licensed competition within a two year period preceding **license** application. **Applicants must receive favorable recommendation(s) from the judge's school clinician(s).**
 3. **Applicants must serve as an Apprentice in the Morgan division at a minimum of one entire Licensed competition with a Federation licensed Morgan judge within two years preceding application. A copy of the Apprentice Report shall be submitted to the Federation Licensed Officials Department and available to the applicant, upon request, in accordance with the Board-approved USEF Guidelines for Education and Licensing. One positive recommendation from the licensed Morgan judge with whom they apprentice is required.**
 4. **Applicants must** receive a passing score of 85% **or higher on an examination administered at the AMHA Judges' School** to be eligible for enrollment. A copy of the Apprentice Judge Report shall be submitted to the Federation Licensed Officials Department. **Applicants may take the final examination three times within a three year period. If an applicant has not passed the examination within three attempts, then the applicant is considered to have failed.**
 5. Exceptions:
 - a. Recorded ('r') Federation licensed judges from any discipline other than Morgan **in another breed or discipline must:**
 - i. Attend two AMHA judge's schools, every day of the first school and two consecutive days of the second school within two years preceding application
 - ii. **Receive favorable recommendation(s) from the judges' school clinician(s) and;**
 - iii. **Pass an examination administered at the AMHA Judges' School with a score of 85% or higher** and receive a passing score to be eligible for enrollment.
 - b. Registered ('R') Federation licensed judges from any discipline other than Morgan **in another breed or discipline must:**
 - i. Attend two days of an AMHA Judges' School within two years preceding application
 - ii. **Receive favorable recommendation(s) from the judges' school clinician(s) and;**
 - i. **Pass an examination administered at the AMHA Judges' School with a score of 85% or higher** and receive a passing score to be eligible for enrollment.
- C. Maintenance Requirements
1. Recorded ('r') Morgan Judges must attend a Federation/AMHA Judges' School at least once every three years.
 2. Judges licensed in the Morgan Division and all persons applying for enrollment, re-enrollment or promotion must take **pass** an examination **administered at the AMHA Judges' School with a score of 85% or higher** and receive a passing score in order to fulfill the judges' clinic and/or judges' school requirement **every three years.**

Section 13.2 Requirements to Obtain 'R' Status

- A. Eligibility Requirements
1. **Applicants must be a current member in good standing with the AMHA.**
 2. **Applicants must have maintained a Federation 'r' Morgan license for at least 12 months prior to 'R' license application.**
- B. Application Requirements
1. **Applicants must complete the application requirements in the order defined below.**
 2. **Applicants must officiate at:**
 - a. **A minimum of two Federation licensed competitions, each with 100 Morgans entered, OR;**
 - b. **A minimum of two Federation licensed competitions, each with at least 25 Morgan classes and each class must have a minimum of five horses.**
 3. **Applicants must complete a final examination with a score of 85% or higher.**

4. No applicant will be considered for promotion unless he has adjudicated in at least two Licensed Competitions during the past three years in the division in which he is licensed, verified by stewards' reports.

C. Maintenance Requirements

1. Registered ('R') Morgan Judges must attend **one of the following clinic options every five years:**
 - a. Attend a Federation/AMHA Judges' School at least once every five years, OR;
 - b. Attend a judges' clinic once every five years at the AMHA convention.
2. **Judges must pass an examination with a score of 85% or higher at the Federation/AMHA Judges' School or Judges' Clinic every five years.**
3. All Registered ('R') and Recorded (r) Federation judges holding a Morgan card must be a current member in good standing of the American Morgan Horse Association.

Section 13. National Show Horse Judges. (previously GR1069 National Show Horse Judges)

1. Apprentice judge at a minimum of two Federation Licensed Competitions, under a minimum of two different Federation National Show Horse judges, within a two-year period preceding application.
 - a. If already a licensed judge in the Hackney, Roadster, Morgan, American Saddlebred, Saddle Seat Equitation, or Arabian divisions he/she may obtain a National Show Horse license by enrolling as per the respective division requirements and Apprentice judging a minimum of five classes in the National Show Horse division at a Federation Licensed Competition.
 1. Registered (R) judges in the American Saddlebred or Arabian divisions are not required to complete any Apprentice judging prior to applying for a license in the National Show Horse division.
2. All persons applying for enrollment or re-enrollment must have attended a Federation National Show Horse judges clinic within 2 years preceding application.
3. Judges must attend a Federation National Show Horse judges' clinic at least once every four years and receive a passing score of 85% or higher on a written examination every four years.
4. National Show Horse Judges do not have officiating requirements, but will be required to complete the clinic and exam requirements or the license will not be renewed.
5. No applicant will be considered for promotion unless he has adjudicated in at least two Licensed Competitions during the past three years in the National Show Horse division, verified by stewards' reports.

Section 14. Para-Equestrian Classifiers. (previously GR1071 Para-Equestrian Classifiers)

A. Eligibility Requirements

1. **Hold a current license as a physical therapist or medical doctor with experience carrying out the assessment of persons with physical impairments resulting in activity restrictions; and**
2. **Have current professional liability insurance.**
3. **Provide USEF with documentation of the observation of a minimum of one Para-Equestrian classification performed by a USEF or FEI licensed Para-Equestrian Classifier**

B. Application Requirements

1. No application will be considered unless and until ten (10) forms which actually evaluate the applicant per division are returned to the Federation, including a minimum of three (3) from Physical Therapists or Licensed Physicians with experience carrying out the assessment of persons with physical impairments resulting in activity restrictions, two (2) personal references, and five (5) from members of the Federation.
2. Applicants must **complete the following requirements within three years preceding application:**
 - i. As verified by the Federation, hold a current license as a Physical Therapist or Licensed Physician with experience carrying out the assessment of persons with physical impairments resulting in activity restrictions;
 - ii. Meet the other requirements listed on the Federation website www.usef.org; and
 - iii. Successfully complete the Para-Equestrian Classifier Course approved by the Federation Licensed Officials Committee. Information on the application procedure is available on the Federation website www.usef.org and also from the Federation office.

iv. Submit six completed Para-Equestrian Classification Cards to a FEI Classifier within two months of completing the Course.

- 1. The FEI Classifier shall review each Classification Card for accuracy, including the grade/grade status given to the athlete by the Applicant and provide comments back to the Applicant.*
- 2. The FEI Classifier shall forward the completed Para-Equestrian Classification Cards to the Licensed Officials Department within four months of the Course completion*

C. Maintenance Requirements

1. Para-Equestrian Classifiers must attend a Federation Para-Equestrian Classifier Training Course at least once every three years.
2. In the event that a Para-Equestrian Classifier Training Course is not being offered in a year that a Classifier is due to take the Course, the deadline will automatically be extended to the following year.

Section 15. Paso Fino Judges. (previously GR1070 Paso Fino Judges)

Section 15.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

- 1. Applicants must be a current member in good standing with the Paso Fino Horse Association (PFHA).*
- 2. Judges in the Paso Fino Division must be at least 25 years of age.*
- 3. Applicants for enrollment in the Paso Fino Division will not be considered unless they are must be licensed as a Certified or Senior Certified Judge by the PFHA and current on PFHA Judge's dues.*

B. Application Requirements

- 1. Applicants may complete the following requirements in any order.*
- 2. Applicants must attend a Federation/PFHA clinic within three years preceding application.*
- 3. and Applicants must pass an open book written examination administered at the clinic on USEF General Rules and responsibilities, receiving with a score of 85% or better higher on Federation General and Paso Fino rules. The examination may be administered at the clinic. If individual an applicant does not receive a passing score then he is required to must attend another Federation/PFHA clinic and take pass an examination at the clinic.*
- 4. Applicants must be recommended in writing by the PFHA Judges & Stewards Committee and certify that the applicant is Active and in Good Standing Status as a PFHA Judge.*

C. Maintenance Requirements

- 1. Judges must be a current member in good standing with PFHA, hold an active license as a PFHA Certified or Senior Certified Judge and must be current with PFHA Judges dues.*
- 2. Recorded (r) or Registered (R) Judges who hold a Certified Judge (C) PFHA license are required to must attend a Federation/PFHA clinic at least once every two years. Judges who hold a Senior Certified PFHA license must attend a Federation/PFHA clinic at least once every three years.*
- 3. Recorded (r) or Registered (R) Judges are required to take must pass a written examination with a score of 85% or higher to be administered once every three years and receive a score of 85% or better before their license is renewed. The exam will be administered to all Paso Fino judges starting in the 2008 competition year and then to all judges every three years thereafter. If an individual does not receive a passing score on the examination then he is required to attend another PFHA/Federation clinic and take an examination at the clinic. Judges who do not pass the examination on their first attempt will have the opportunity to retake the examination one additional time. If a judge does not receive a passing score on the make-up exam, then he must attend another Federation/PFHA clinic and pass an examination at the clinic with a score of 85% or higher before their license is renewed.*
- 4. The Committee will require Judges who do not must officiate at one Federation licensed competition in the Paso Fino Division within every three years in the Paso Fino division after obtaining a license or for any three year period thereafter, to re-apply for a license.*

Section 15.2 Requirements to Obtain 'R' Status

A. Eligibility Requirements

- 1. Applicants must be a current member in good standing with the PFHA.*

2. **Applicants must be licensed as an active Senior Certified Judge by the PFHA and current on PFHA Judge's dues.**
 3. Applicants for promotion must have adjudicated in at least six Federation Licensed competitions **in the Paso Fino Division within the past three years prior to application**, verified by stewards' reports. At least two of the six competitions must have **had** a minimum of 100 **Paso Fino** horses competing for the applicant to be eligible for promotion.
- B. Application Requirements
1. **Applicants must complete the application requirements in the order defined below.**
 2. **Applicants must attend a Federation/PFHA clinic within three years preceding application.**
 3. ~~Applicants for change of status must have completed a written exam administered by the Federation on USEF General Rules and responsibilities to USEF within past two years and received a score of 85% or better.~~
 4. **Applicants must pass an open book written examination with a score of 85% or higher on Federation General and Paso Fino rules. The final examination may be administered at a clinic. If an applicant does not receive a passing score, he must attend another PFHA/Federation clinic and pass an examination at the clinic.**
 5. **The applicant must be recommended in writing by the PFHA Judges & Stewards Committee and certify that the applicant is Active and in Good Standing Status as a PFHA Senior Certified Judge.**
- C. Maintenance Requirements
1. All Registered (R) and Recorded (r) USEF Judges holding a Paso Fino card must be a current member in good standing with PFHA, **hold an active license as a PFHA Senior Certified Judge and must be current with PFHA Judges dues.**
 2. Recorded (r) or Registered (R) Judges who hold a Senior Certified PFHA license are required to **must** attend a Federation/PFHA clinic at least once every three years.
 3. **Judges must receive a passing score of 85% or better on an examination every three years. Judges who do not pass the examination on their first attempt will have the opportunity to retake the exam one additional time. If a judge does not receive a passing score on the make-up exam, then he/she must attend another PFHA/Federation clinic and take an examination at the clinic and receive a score of 85% or better before their license is renewed.**
 4. **Judges must officiate at one Federation licensed competition in the Paso Fino Division every three years.**

Section 16. Reining Judges. ~~(previously GR1072 Reining Judges)~~

Section 16.1 Requirements to Obtain 'R' Status

- A. Eligibility Requirements
1. **Applicants must be a current member in good standing with USA Reining.**
- B. Application Requirements

g. **Stewards must maintain their USHJA membership annually.**

2. ~~The Measurement Exam~~

a. ~~Steward clinics must include a live measurement exam. Stewards who officiate at USEF competitions that hold divisions where measurement is required must pass the exam with a score of 85% or higher.~~

b. ~~There will be 2 categories of stewards related to measurement.~~

1. ~~Measuring Steward — one who has passed the measurement exam at a clinic with a score of 85% or higher.~~

a. ~~May steward at any competition where their license qualifies.~~

b. ~~At least one Measuring Steward must be hired at competitions that hold divisions where measurement is required.~~

c. ~~Stewards scoring 93% or higher on the measurement exam will be exempt from taking the measurement exam at their next required clinic, but will be required to pass the measurement exam at the subsequent required clinic. Exception: If said Steward has had measurement errors which require action by the LOC or the Hearing Committee, they~~

may be asked to perform additional testing prior to the next required clinic where they are scheduled to test for measurement.

2. ~~Non-measuring Steward— one who chooses not to take the measurement exam or who receives below 85% on the measurement exam. This steward:~~
 - a. ~~May officiate alone at breed or discipline competitions that have no divisions which require measurement.~~
 - b. ~~May officiate on a multi-steward panel at a competition with breed or discipline divisions requiring measurement, provided the competition has already hired a measuring steward.~~
 - c. ~~May not measure any animal at any USEF rated competition.~~
3. ~~A Non-measuring Steward may attain Measuring status upon successful completion of a Measurement Exam offered at a Steward's clinic.~~
4. ~~Measurement appeals: A Steward who scores a 93% or higher on the measurement exam will be certified to measure for measurement appeals. Only Stewards certified to measure may be called upon for a measurement appeal.~~

3. ~~Written examination~~

- a. ~~Registered and recorded Category 1 and Category 2 stewards must take the corresponding Category 1 or Category 2 Federation stewards' examination once every (3) three years and must receive a mark of 85% or higher before their license is renewed.~~
- b. ~~The method of administration will be decided by the Federation Licensed Officials Committee.~~

4. ~~Continuing Education:~~

- a. ~~Registered and Recorded Category 1 and Category 2 stewards must complete yearly continuing education as required by the Federation Licensed Officials Committee. These continuing education modules along with corresponding quizzes will be offered on the United States Equestrian Federation website and must be taken and passed with a score of 85% or higher. Failure to complete this requirement will prevent a steward from renewing their license.~~

Section 21.1.2 Requirements to Obtain 'R' Status

A. Eligibility Requirements

1. ***Applicants must be a current member in good standing with the USHJA.***

B. Application Requirements

1. ***Applicants may complete the following requirements in any order.***
2. ***Officiate as a Category 1 steward in at least ten Federation licensed Hunter/Jumper competitions within the past five years.***
3. ***Must have documented experience of having served as the Certified Schooling Supervisor or an apprentice schooling supervisor at four classes offering \$25,000 for more. The Schooling Supervisor's Documentation of Experience should be filled out by the Schooling Supervisor and submitted along with the application for promotion.***
4. ***Applicants must complete the examination with a minimum score of 85%.***

C. ***Maintenance Requirements***

1. ***Stewards must pass an annual examination with a score of 85% or higher.***
2. ***Stewards must attend a Category 1 Federation Stewards clinic every four years.***
 - i. ***Stewards scoring 93% or higher on the measurement exam will be exempt from taking the measurement exam at their next required clinic, but will be required to pass the measurement exam at the subsequent required clinic. Exception: If said Steward has had measurement errors which require action by the LOC or the Hearing Committee, they may be asked to perform additional testing prior to the next required clinic where they are scheduled to test for measurement.***
3. ***Stewards must officiate at three Federation licensed Hunter/Jumper competitions every three years.***
4. ***Stewards must maintain their USHJA membership annually.***

Section 21.2 Category 2 (C2) Stewards

Section 21.2.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

1. **Must have been a participant in the past eight years at a minimum of six USEF Breed competitions in at least one of the following positions: competitor, trainer, owner, licensed official, competition employee (i.e. in-gate personnel, ring crew), competition official (including but not limited to those listed in GR113), or other interested party with experience with Breed competitions.**
 - i. **Exception: Applicants who hold a C1 Steward or Dressage Technical Delegate license may apply for the C2 Training Program with documented experience in one of the above roles at a minimum of three USEF Breed shows.**

B. Application Requirements

1. **Applicants must complete the requirements in the order defined below.**
2. **Online Training**
 - i. **Applicants must complete the Online Applicant Training consisting of power point presentations, short quizzes, and videos.**
 - ii. **Applicants must contact the USEF to receive access to the Online Applicant Training.**
 - iii. **Apprentice work completed prior to completing the Online Applicant Training will not count.**
3. **Apprenticing**
 - i. **All apprenticing must be completed within three years from the start of the online training.**
 - ii. **A minimum of 10 complete/full complete days at a minimum of four different USEF licensed Breed competitions (Exception: C1 Stewards and Dressage Technical Delegates must complete a minimum of six complete/full days at a minimum of two different USEF licensed Breed competitions with two different 'R' C2 Stewards.)**
 - iii. **The applicant must apprentice at least once in the each of the following divisions: Arabian, Morgan, American Saddlebred, Saddle Seat Equitation, Western, and Western Seat/Reining Seat Equitation.**
 - iv. **Recognized Working Western classes for Arabian and/or Morgan horses will fulfill the Western, Western Seat/Reining Seat Equitation requirement.**
 - v. **Applicants must apprentice in at least one of the following divisions: Andalusian/Lusitano, Friesian, Paso Fino, Hackney Harness, Roadster, Shetland, or National Show Horse.**
 - vi. **The applicant must work with a minimum of four different 'R' Category 2 Stewards.**
 - vii. **The applicant must also apprentice with an 'R' Dressage Technical Delegate for a minimum of one day at a licensed Dressage Competition. This cannot be accomplished at a breed restricted Dressage competition. (NOTE: This is not required for licensed Dressage TDs.)**
 - viii. **If applying to be a Measurement Steward, while apprenticing, the applicant must complete practice measurements of at least five horses or ponies. These five practice measurements must be accomplished prior to the live evaluation of measurement conducted at a clinic.**
 - ix. **All apprentice evaluations and practice measurement forms must be completed and signed by the C2 with whom the applicant was apprenticing with.**
4. **Clinic**
 - i. **Applicants must attend a live Federation Category 2 Stewards' Clinic within three years of the start of the online training.**
 1. **Attendance must be accomplished only after an applicant has completed both the Online Applicant Training and apprenticing.**
 2. **The clinic must be attended within 12 months of the applicant completing their apprenticing.**
 - ii. **Measurement Clinic and Information**
 1. **Applicants who wish to be certified to measure must complete the live measurement evaluation at a Steward's Measurement Clinic and pass with a score of 85% or higher.**
 2. **A Non-measuring Steward is an individual one chooses not to take the measurement exam or who receives below 85% on the measurement exam.**
 3. **A Non-measuring Steward may attain Measuring status upon successful completion of a Measurement Exam with a score of 85% or higher at a Steward's clinic.**
5. **Final Examination**
 - i. **An exam will be sent to the applicant upon notification by the applicant to USEF that they have completed the steps listed above. The applicant must return the exam to the Licensed**

Officials Department within 30 days of receipt and successfully complete the examination with a minimum score of 85%.

C. Maintenance Requirements

1. Officiating requirements:

i. ~~The Licensed Officials Committee will require Category 2 Stewards who do not~~ **must** officiate at a minimum of three **Federation** licensed competitions in the C2 group within **every** three years after obtaining a license or for any three-year period thereafter, to re-apply for a license.

2. **Stewards must pass an annual examination with a score of 85% or higher.**

3. **Stewards must attend a Category 2 Federation Stewards clinic every four years.**

i. **Stewards scoring 93% or higher on the measurement exam will be exempt from taking the measurement exam at their next required clinic, but will be required to pass the measurement exam at the subsequent required clinic. Exception: If said Steward has had measurement errors which require action by the LOC or the Hearing Committee, they may be asked to perform additional testing prior to the next required clinic where they are scheduled to test for measurement.**

Section 21.2.2 Requirements to Obtain 'R' Status

A. Eligibility Requirements

1. **Applicants are not required to meet any additional eligibility requirements besides those defined in Chapter 10 of the Federation rulebook and/or the Licensed Official Policies and Procedures.**

B. Application Requirements

1. **Must officiate as a C2 Steward for five Federation licensed competitions within the past three years.**

2. **Applicants must pass a final examination with score of 85% or higher.**

C. Maintenance Requirements

1. **Stewards must officiate at three Federation licensed competitions every three years.**

2. **Stewards must pass an annual examination with a score of 85% or higher.**

3. **Stewards must attend a Category 2 Federation Stewards clinic every four years.**

i. **Stewards scoring 93% or higher on the measurement exam will be exempt from taking the measurement exam at their next required clinic, but will be required to pass the measurement exam at the subsequent required clinic. Exception: If said Steward has had measurement errors which require action by the LOC or the Hearing Committee, they may be asked to perform additional testing prior to the next required clinic where they are scheduled to test for measurement.**

5. ~~Promotion Procedures.~~

a. ~~Applicants for promotion must have taken an examination and receive a mark of 85% or higher within the past 24 months.~~

b. ~~Category 1~~

1. ~~No recorded Category 1 steward will be considered for promotion unless the applicant has officiated as a Category 1 steward in at least ten (10) licensed Hunter/Jumper competitions. Recorded Stewards who wish to apply for Registered status must fulfill this requirement within five (5) years as verified by stewards' reports.~~

2. ~~An applicant for promotion to Registered status as a Category 1 Steward must have documented experience of having served as the Certified Jumper Schooling Supervisor or an apprentice schooling supervisor at four classes offering \$25,000 or more.~~

c. ~~Category 2~~

1. ~~No recorded Category 2 steward will be considered for promotion unless the applicant has officiated as a Category 2 steward in at least five (5) Licensed competitions in the Category 2 group during the past three years, verified by stewards' reports.~~

~~No C2 applicant steward under 25 years of age will be considered for promotion unless he has served as a Recorded Category 2 steward for at least two years (24 months).~~

Section 21.2.3 Requirements to Obtain AHA Designation

A. In order to officiate Federation Licensed AHA approved competitions that are restricted to Arabians and Half/Anglo Arabians, stewards must meet Federation licensing requirements and must also have passed the AHA

approved Arabian stewards test, and also attended a special session for AHA approved Arabian stewards at a Federation stewards clinic.

B. Maintenance

1. C2 Stewards with an AHA Designation must pass a maintenance exam with a score of 85% or higher every three years.

Section 21.2.4 Requirements to Obtain PFHA Designation

- A. In order to officiate Federation Licensed PFHA approved competitions that are restricted to Paso Finos, stewards must meet Federation licensing requirements and must also be certified as a Steward with the Paso Fino Horse Association.

Section 22. Certified Schooling Supervisor. (~~previously GR1077 Stewards—Category 1, Category 2~~)

A. Eligibility Requirements

1. **Applicants are not required to meet any additional eligibility requirements besides those defined in Chapter 10 of the Federation rulebook and/or the Licensed Official Policies and Procedures.**

B. Application Requirements

1. **Applicants may complete the following requirements in any order. However, the final examination must be completed last.**
2. **Applicants must attend a Certified Schooling Supervisor Training Session.**
3. **Applicants must apprentice with two different Certified Schooling Supervisors for a minimum of a total of eight hours. At least two Apprentice Evaluation forms must be returned to the Federation.**
4. **Final Examination**
 - i. **The Final Examination must take place after the Training Session. It will be conducted by one of the following individuals: Larry Alcorn, Ralph Alfano, Maria Biancone, Mary Choate, David Distler, Karen Golding, Peter Lane, Dan Reed, Ron Rhodes, Debbie Sands, Sharon Stewart-Wells, or Eric Straus.**
 - ii. **The Final Exam must be conducted at a Jumper Rating 3 and Hunter rating National competition or above. It will be practical in nature and consist of two parts - Knowledge of the Rules and Officiating.**
 1. **Knowledge of the Rules - Applicants will be evaluated as to their knowledge of the schooling rules. A series of schooling jumps will be presented (some legal, some not) which they will be asked to comment on. This will be done with actual jumps, not pictures.**
 2. **Officiating - Applicants will be evaluated as they officiate as the Schooling Supervisor under the supervision of the Examiner to ascertain their ability to do the job correctly.**
 - iii. **Applicants must contact an Examiner directly to arrange a time and place for the examination.**
 - iv. **Applicants should be prepared to spend a full day completing the Final Examination (maximum of two applicants per exam).**
 - v. **The Applicant must pass the Final Exam with a score of 85% or higher.**

C. Maintenance Requirements

1. **Certified Schooling Supervisors must attend a CSS Training Session every four years.**
2. **Certified Schooling Supervisors must officiate at four Federation licensed competitions every four years.**

Section 23. Vaulting.

Section 23.1 – Judges. (~~previously GR1078 Vaulting Judges~~)

Section 23.1.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

1. Applicants for enrollment in the Vaulting Division will not be considered unless they are licensed by the FEI in Vaulting, licensed by the American Vaulting Association, or have successfully completed a training program for vaulting judges approved by Federation and the AVA.

B. Application Requirements

1. **Applicants must attend a Federation/AVA Judges' Forum.**
2. **Applicants must pass a final examination with a score of 85% or higher.**

C. Maintenance Requirements

1. All Vaulting Judges must attend the **a** Federation/AVA Judges Forum **annually** each year or AVA Judges Training sessions of equal hours.
2. Vaulting Judges must hold a current AVA judges' card and must judge **officiate** at least one **Federation** licensed competition once every five years or the license will not be renewed.

Section 23.1.2 Requirements to Obtain 'R' Status

A. Eligibility Requirements

1. **Applicants are not required to meet any additional eligibility requirements besides those defined in Chapter 10 of the Federation rulebook and/or the Licensed Official Policies and Procedures.**

Section 23.2.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

Applicants for enrollment as Vaulting Technical Delegates will not be considered unless they are licensed by the FEI in the Vaulting division or licensed by the AVA as a Vaulting judge, or have successfully apprenticed at a minimum of one USEF or FEI Vaulting competition within the two years prior to applying for the license or have attended an approved continuing education clinic for vaulting technical delegates within the two years prior to applying for the license.
2. **Applicants must be a current member in good standing with the American Vaulting Association (AVA).**

B. Application Requirements

1. **Applicants may complete the following requirements in any order. However, the final examination must be completed last.**
2. **Apprentice at a minimum of one Federation or FEI Vaulting competition within two years preceding application.**
3. **Attend an approved continuing education clinic for vaulting technical delegates within the two years prior to applying for the license.**
4. **Applicants must pass a final examination with a score of 85% or higher.**

C. Maintenance Requirements

1. Vaulting Technical Delegates must attend a Federation approved continuing education clinic for vaulting technical delegates at least once every four years; successful completion of a written exam may be required as part of the clinic requirement.
2. ~~The Licensed Officials Committee will require~~ Vaulting Technical Delegates who do not **must** officiate at a minimum of one **Federation** licensed vaulting competition every five years after obtaining a license to re-apply for a license.
3. ~~Vaulting Technical Delegates must be members in good standing of the American Vaulting Association.~~

Section 24. Welsh Pony Judges. ~~(previously GR1080 Welsh Pony Judges)~~

Section 24.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

1. **Applicants must be a current member in good standing with the Welsh Pony and Cob Society of America (WPCSA).**
2. ~~In the Welsh Pony Division, all Applicants must have had experience breeding, training or showing Welsh ponies and must be recommended by the Welsh Pony and Cob Society of America, Inc. (WPCSA).~~

B. Application Requirements

1. **Applicants may complete the following requirements in any order. However, the final examination must be completed last.**

2. Applicants must complete three full days of **apprenticing** judging in the Welsh division at a minimum of three Federation licensed competitions under a minimum of three separate Registered Welsh judges.
 - i. Registered Hunter Judges may complete three full days of judging in the Welsh Division at a minimum of three Federation Licensed Competitions per GR1004.6 to fulfill their apprentice judging requirements.
 - ii. Current approved WPCSA judges must complete a minimum of one full day of apprentice judging in the Welsh Division at a Federation Licensed Competition.
3. Applicants must have attended a Federation **Welsh** judges' clinic within three years preceding application.
4. **Applicants must pass a final examination with a score of 85% or higher.**
5. For an applicant in the Welsh Division who holds approved status with the WPCSA, the Licensed Officials Committee shall have the option of granting Registered status.

C. Maintenance Requirements

1. ~~Licensed USEF Welsh Judges must attend a Federation Welsh Judges' Clinic every five years to retain their license.~~
2. ~~Welsh Judges must judge **officiate** at least one in the Welsh division **at one Federation licensed competition** every five years or the license will not be renewed.~~

Section 24.2 Requirements to Obtain 'R' Status

2. ~~All Registered (R) and Recorded (r) USEF Welsh judges must be current members in good standing of the WPCSA.~~
3. **Applicants must pass a final examination with a score of 85% or higher.**

C. Maintenance Requirements

1. **Judges must attend a Federation Welsh Judges' Clinic every five years.**
2. **Judges must officiate in the Welsh division at one Federation licensed competition every five years.**

Section 25. Western Judges. (previously GR1081 Western Judges)

Section 25.1 Requirements to Obtain 'R' Status

A. Eligibility Requirements

1. **Applicants are not required to meet any additional eligibility requirements besides those defined in Chapter 10 of the Federation rulebook and/or the Licensed Official Policies and Procedures.**

B. Application Requirements

1. **Applicants may complete the following requirements in any order. However, the final examination must be completed last.**
2. Apprentice judge at a minimum of two Federation licensed competitions, under minimum of two different Federation Western judges, within a three year period preceding application.
 - i. Exception: Judges holding Federation Reining Division license and/or one or more national breed association judges card(s) are not required to apprentice judge.
3. Attend designated sessions at the International Equine Judges Seminar (IEJS) ~~complete the Federation Western Judges technical training provided via the USEF website.~~
4. **Interview**
 - i. **Applicants must** interview with members of the **Federation's** National Western Committee. Interviews ~~may~~ **will** be conducted via teleconference. **The interview will be scheduled once staff have verified all other requirements have been met.**

- i. ~~Persons holding a national breed association card with an association affiliated with the IEJS must attend designated sessions at the IEJS and interview before submitting an application for enrollment. (Interviews may be conducted via teleconference)~~
- ii. ~~All applicants for enrollment and reenrollment must also pass the rule book test with a score of 84% or better.~~

5. Final Examination

- i. ***The exam is administered online as part of the USEF Western Judge technical training. The Federation online training will consist of a Power Point and the exam will cover USEF General Rules, Western Equitation Rules, and the Western Division Rules. All persons applying for enrollment in this division must pass the examination with a score of 85% or higher.***

- 6. All persons applying for enrollment or re-enrollment must have attended the designated sessions at the IEJS and completed the USEF Western Judges technical training within one year preceding application.
- 7. Applicants approved in the Western Division shall automatically receive Registered status.

C. Maintenance Requirements

- 1. Registered Judges must attend the designated sessions at the IEJS and complete the USEF Western Judges technical training at least once every six years.
- 2. Judges licensed in the Western division must take ***pass*** an examination and receive ***the online Federation Western Judges Technical Training with*** a score of 845% or better ***higher*** on the exam once every six years to maintain their license.
- 3. Western judges do not have officiating requirements, but will be required to complete the USEF Western Judges technical training and testing requirements or the license will not be renewed.
- 4. ***Judges must pass a maintenance exam with a score of 85% or higher every three years.***

Section 26. Western Dressage Judges. ~~(previously GR1082 Western Dressage Judges)~~

Section 26.1 Requirements to Obtain 'r' Status

A. Eligibility Requirements

- 1. ***Applicants must be a current member in good standing with the Western Dressage Association of America (WDAA).*** Every applicant must be a current member in good standing of the Western Dressage Association of America. Once licensed, each judge must maintain membership in good standing of the Western Dressage Association of America.

B. Application Requirements

- 1. ***Applicants must complete the application requirements in the order defined below.***
- 2. ***Applicants must attend all sessions of the WDAA Judges Training Seminar. Applicants must pass a written examination on the USEF rules with a score of 85% or higher as part of the WDAA Judges Training Seminar.***
- 3. ~~Applicants must meet minimum requirements and complete the current training program approved by the Federation Licensed Officials Committee. Information on application procedure and the current program is available on the USEF website www.usef.org and also from the Federation office.~~
- 4. ***Apprenticeship***
 - i. ***Applicants must apprentice at a minimum of three Federation licensed competitions in the Western Dressage division with at least two different Federation Western Dressage judges. The applicant must apprentice at least 60 rides which must meet the following criteria:***
 - 1. ***20 rides at the Intro level (5 of these rides must be Test 3 or Test 4)***
 - 2. ***20 rides at the Basic Level (5 of these rides must be Test 3 or Test 4)***
 - 3. ***20 rides at Level 1 (5 of these rides must be Test 3 or Test 4)***
 - ii. ***The applicant must receive three positive apprentice evaluations with recommendations for licensure. At least two of the positive evaluations must be from different judges.***
 - iii. ***Exception: One Group Apprenticeship at the WDAA World Championship Show may be substituted for two individual apprenticeships at other Federation licensed competitions. Applicants may only Group Apprentice once when applying for 'r' status.***
- 5. ***Applicants must receive a "satisfactory" evaluation on the WDAA online final examination.***
- 6. ***Applicant must receive a recommendation to approve licensure from the WDAA.***

C. Maintenance Requirements

1. All Western Dressage Judges must **attend** participate in and successfully complete all requirements of a Federation Western Dressage **certain designated sessions of a WDAA Judges Training Seminar** continuing education clinic at least once every three years.
2. All Western Dressage Judges must satisfactorily complete **pass** a written examination **with a score of 85% or higher** once every three years **as part of the WDAA Judges Training Seminar** with a minimum passing score of 85%. The exam will be administered by USEF once in each three year period.
3. ~~At the request of the Federation, a judge may be required to attend a continuing education clinic, outside of his regular rotation or may be asked to complete additional testing.~~

Section 26.2 Requirements to Obtain 'R' Status

3. **Applicants must attend all sessions of the WDAA Judges Training Seminar.**
4. **Apprenticeship**
 - i. **Applicants must apprentice at least three USEF licensed competitions in the Western Dressage division with at least two different USEF Western Dressage judges. At these competitions, the applicant must apprentice at least 20 rides which must meet the following criteria:**
 1. **15 rides at Level 2 or above**
 2. **5 rides at Level 3 or above**
 - ii. **The applicant must receive three positive apprentice evaluations with recommendations for licensure. At least two of the positive evaluations must be from different judges.**
 - iii. **Exception: One Group Apprenticeship at the WDAA World Championship Show may be substituted for two individual apprenticeships at other USEF competitions. Applicants may only Group Apprentice once when applying for 'R' status.**
5. **Applicants must pass a written examination on the Federation Rules with a score of 85% or higher as part of the WDAA Judges Training Seminar.**
6. **Applicant must receive a recommendation to approve licensure from the WDAA.**

C. Maintenance Requirements

1. **Judges must attend certain designated sessions of a WDAA Judges Training Seminar every three years.**
2. **Judges must pass a written examination on the Federation Rules with a score of 85% or higher every three years as part of the WDAA Judges Training Seminar.**
