5. HORSE RECORDING

Recording your horse/pony automatically enters it in the USEF Horse of the Year Program provided the owner is an Active member or recorded Farm/Business of the Federation and USHJA (if applicable). Horses must be recorded to compete at certain USEF National Championships.

LIFETIME RECORDING

- \$35** Birth to December 31st of year foaled
Age discount requires proof of age (i.e. registration papers).
- \$300** Horses one year of age or older

ANNUAL RECORDING

- \$95** 2021 Recording
Annual Recordings are effective for 12 months from the start date.

6. USHJA REGISTRATION

You are required to have a USHJA Horse Registration number to compete in hunter, jumper, and/or hunter seat equitation classes at any non-breed restricted USEF Licensed Competition. Exceptions to this rule are listed in GR901.9, items 1-9.

- \$75** (lifetime registration)
- NOTE:** In order to receive USEF points, a horse must be recorded with USEF and registered with USHJA. If your horse already has a USHJA Registration, you do not need to reapply.

7. AMERICAN PERFORMANCE HORSE (APH)

Want to recognize your American-bred horses? Simply submit a copy of your breed papers and a processing fee of \$10.
