PASSPORT SERVICE APPLICATION

Please use this new application for all of your FEI or National Passport needs. As always, if you have questions please contact the office.
A Passport Representative will be happy to assist you!

GETTING STARTED . . .

1. The horse must be USEF Life Recorded. If your horse is not recorded, please select the Life Recording option below. If your horse is Annually Recorded, please select Upgrade to Life.
2. Owners must be United States citizens and have a USEF Junior or Senior Active Membership. If one or more owners are not US citizens, please contact the Passport Department.
3. All owners listed in the Passport must be listed as owners with USEF.
4. If the horse has an approved breed or national passport, it must be submitted with the application.
5. If you are competing in an FEI International Competition, please note that FEI Registrations for horse and rider are mandatory. They may be submitted with this application.
6. All horses obtaining their initial FEI Registration are required to have an ISO 11784/11785 compatible microchip.
7. For ponies that do not have an official USEF measurement card at the time of Passport application, it is required that one is obtained at the pony's first competition. For pony's that do not have a permanent measurement card, be sure to fill in the height of the pony on the application.
8. Expedited Passport Service guarantees three (3) business day turnaround providing all necessary documentation has been provided at the time of submission. Passport services that involve either a foreign National Federation or FEI approval are available for the expedited service but keep in mind the timing will depend on the responsiveness of the foreign NF and/or the FEI. The \$300 expedited fee is non-refundable even when requirements are not met so please review all of the requirements carefully before requesting this service.
9. Expedited passports will be mailed out with UPS overnight shipping. These packages are insured for the value of the passports in them. Passports that are not Expedited will be mailed out USPS Two Day Priority shipping. Please note, these packages are NOT insured. You may request UPS shipping on passports that are not Expedited by checking this option on the Service Menu below. The cost of this is \$60.

HORSE NAME CHANGE GUIDELINES

Horse Name Change – Any modification/change to the current name of the horse or the creation of a different current name that is different than the Horse Birth Name. Each horse name change submitted to the FEI will be invoiced including:

- Horse created with an FEI ID only
- Horse created with FEI Passport
- Horse created with USEF National Passport
- Horse that is upgraded from FEI ID only to FEI Passport/Recognition Card
- Horse created with FEI Recognition Card

Change Back to Birth Name and National Sport Name – Free of Charge

1. Change from the horse's current name back to the horse's birth name.
2. Use of the National Sport Name if in accordance to the following criteria:
 - a. Creation of a new horse in the FEI database
 - b. The horse must have competed regularly at the national level for at least 12 months
 - c. The National Sport Name does not fall into the commercial name category

Change of Horse Name and Commercial Name - \$1250

1. Complete change of current name
2. Current name that differs from birth name and is not the National Sport Name
3. Commercial name includes: a company/brand, stable, group of persons/associations, and/or a person's initials.

Addition of Non-Commercial Initials or Name Shortening - \$250

1. Addition of non-commercial initials
2. Name shortening

What is a Horse Birth Name?

1. The name of the horse in the initial document issued at birth
2. If (1.) is not applicable, the name of the horse in the first birth studbook document.
3. If the horse is not affiliated with any studbook, the name of the horse is based on the name written in the first document issued (either national passport/first original document, or FEI recognized document, or FEI Passport)

NOTES WHEN MAILING PASSPORTS:

- **DO NOT ADDRESS PACKAGES "ATTN: PASSPORTS"**
MAIL SORTING SERVICES SOMETIMES FLAG THESE PACKAGES AT THE POST OFFICE TO GO TO SEPARATE PASSPORT OFFICES IN THE SAME MAIL FACILITY AND THIS CAN CAUSE DELIVERY DELAYS.
- **DO NOT SEND PACKAGES WITH SIGNATURE REQUIRED ON DELIVERY**
THIS PREVENTS OUR MAIL CARRIERS FROM BEING ABLE TO DELIVER PACKAGES AFTER HOURS OR ON THE WEEKENDS AND CAN CAUSE DELIVERY DELAYS.
- **PACKAGES WILL ALSO BE RETURNED WITHOUT SIGNATURE REQUIRED UPON DELIVERY UNLESS REQUESTED OTHERWISE.**
