The Licensed Officials Department has received feedback that FEI Jumping Stewards from outside of the United States are not as familiar with Federation national rules and reporting requirements for Federation licensed competitions. Although FEI Jumping Stewards can be excellent officials, since Certified Schooling Supervisors can also be responsible for hunter schooling areas, it has become a fairness and safety concern if foreign FEI Jumping Stewards have not received training on USEF rules or are comfortable with both the hunter and jumper disciplines.

GR1005 Officiating Eligibility and Guest Cards

10. Certified Schooling Supervisors

a. *U.S.* FEI Jumping Stewards are eligible to serve as Certified Schooling Supervisors *in hunter, equitation, or jumper schooling areas. Foreign FEI Jumping Stewards are only eligible to serve as Certified Schooling Supervisors in jumper schooling areas.*
