

### DISCIPLINARY ACTION COMPLAINT FORM

Following receipt of notice that the Federation declined to pursue disciplinary action concerning a reported violation of Federation rules/regulations, Part VII of the Federation Bylaws provides the process by which the reporting party (if a Licensed Official, Life, Senior Active, or parent of Junior Active member) may file a Disciplinary Action Complaint with the Federation Regulation Department, and assume responsibility for all aspects of pursuing the matter, including without limitation the reporting party's expenses in pursuing such matter. This complaint form must be used when filing a Disciplinary Action Complaint. A complaint that is not filed in accordance with Federation Bylaws shall render the filing ineffective and the complaint shall not be considered to have been properly filed. The complaint shall be filed with the Federation Regulation Department at <a href="mailto:disputes@usef.org">disputes@usef.org</a>. Bylaw 707 prohibits retaliation against anyone who files a complaint or report under the procedure in the Bylaws. Retaliation is considered a violation of the Federation rules and grounds for discipline.
