The final list of Selection Trials will be published as part of the approved Eventing Selection Procedure for the 2019 Pan American Games. The 2019 Pan American Games (CCI2*) will take place in Lima, Peru July 26- August 11, 2019. Additional events may be added. Notification of additional events will be no less than 30 days prior to the competition.
