Application Athletes wishing to participate in the NAJYRC must complete an Application (Attachment A); and return it with the appropriate fee per application to the United States Equestrian Federation (USEF), 4047 Iron Works Parkway, Lexington, KY 40511.Application and fees postmarked, delivered, faxed on or prior to May 2, 2017 will be charged \$50 per application. Applications and fees postmarked, delivered, faxed or submitted online after May 2, 2017 and received by USEF on or before May 16, 2017 will be charged an application fee of \$300 per application. Athletes are permitted to compete with only those horses named on the athlete's application. Completed applications must be submitted with payment to the USEF office by the above stated deadline. NO APPLICATIONS WILL BE ACCEPTED AFTER May 16, 2017.
- b. Additional horses may be added to an already received application until June 1, 2017 for \$50 each.
