RE: Preliminary Notice to the Athlete Selection Procedures for the Lima 2027 Pan American Games.

To provide information in a timely manner, US Equestrian is releasing this Preliminary Notice to the Athlete Selection Procedures for the 2027 Pan American Games (Games). This document is being written as a complement, and not a substitute to the 2027 Pan American Games Athlete Selection Procedures. Additional communication will be released by US Equestrian (NGB) once the Athlete Selection Procedures have been approved by the USOPC. Please remember that this information is based upon the recommendations of the Eventing Sport Committee and are subject to approval by the USEF Board of Directors, Executive Committee, or an Ad Hoc Selection Group approved by the USEF Board of Directors.

The 2027 Pan American Games ("Games") will take place in Lima, Peru. The Games will run from July 23-August 8, 2027, with the Eventing dates TBD.

A. Anticipated Athlete Eligibility Criteria:

- Athletes must comply with all Federation Equestre International (FEI) and Pan Am Sports Organization (PASO) eligibility requirements which will be posted here once available:

- Athletes must be a national of the United States and hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.
- Athletes must adhere to all NGB, USADA, USOPC, WADA, and Panam Sports anti-doping protocols, policies, and procedures including participation in Out-of-Competition Testing, if applicable.
- Athletes must comply with the USOPC Background Check Policy and USOPC Athlete Safety Policy.
- The 2027 Pan American Games will run at the CCI3* level for the cross-country test and at the CCI4* level for the dressage and jumping tests. With this consideration, an additional qualifying result (MER) is required at a CCI4*-S or a USEF Advanced Horse Trial for Athlete/Horse combinations that have only completed a CCI3*-L between January 1, 2026, and a date to be confirmed once the FEI nominated date is released.





B. FEI/PASO Qualification System Overview:

The 2027 Pan American Games Qualification Systems Manual for Eventing has not been published by the FEI/PASO so the maximum Team size cannot be confirmed at this time.

C. Anticipated Evaluation Events:

It is intended that athletes being considered for nomination to the 2027 Pan American Games will be evaluated on their performance at any of the below listed events.
